1. DETAILS OF THE BUYBACK OFFER AND OFFER PRICE

The board of birectors of Tips Industries Limited (the "Company") (the board of directors of the Company hereinafter referred to as the "Board", which expression shall include any committee constituted and authorized by the Board to exercise its owers), at their meeting held on February 13, 2020 and Buyback Committee meeting dated March 11, 2020 (the "Board Meeting") has, subject to the approval of the shareholders of the Company by way of a special resolution through a postal ballot e-voting, pursuant to the provisions of Article 6 of the Articles of Association of the Company, Sections 68,69,70,110 and all other applicable provisions, if any, of the Companies Act, 2013, as amended (the "Companies Act"), the Companies (Share Capital and Debentures) Rules, 2014 (Share Capital Rules), the Companies (Management and Administration) Rules, 2014 ("Management Rules") to the extent applicable, and in compliance with Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), the Buyback Regulations and subject to such approvals of statutory, regulatory or governmental authorities as may be required under applicable laws, approved the buyback by the Company of up to 13,50,000 (Thirteen Lakhs Fifty Thousand) fully paid up Equity Shares of ₹ 10/- (Rupees Ten only) representing up to 9.43% of the total issued and paid-up Equity Share capital of the Company as per the latest audited condensed interim standalone financial statements for the nine months period ended December 31, 2019 of the Company (the "Audited Financial Statements" at a price of ₹ 140/- (Rupees One Hundred and Forty only) per Equity Share "Buyback Price") payable in cash for an aggregate consideration of up to ₹ 18.90.00.000/- (Rupees Eighteen Crores Ninety lakhs only) ("Buyback Size"), which is upto 24.62% (within statutory limit of 25%) of the fully paid up Equity Share capita and free reserves as per the Audited Financial Statements on a proportionate basis through the "tender offer" route as prescribed under the Buyback Regulations, to all of the shareholders of the Company who hold Equity Shares as of Friday, April 3, 2020, ("Record Date") ("Buyback").

- 1.2 The Buyback Size does not include any transaction costs viz. brokerage, applicable taxes inter alia including buy back taxes, securities transaction tax, GST, stamp duty, expenses incurred or to be incurred for the Buyback like filing fees payable to Securities and Exchange Board of India ("SEBI"), advisors/legal fees, public announcement publication expenses, printing and dispatch expenses and other incidental and related expenses, etc. ("Transaction Cost").
- 1.3 The Equity Shares are listed on the BSE Limited (the "BSE") and the National Stock Exchange of India Limited (the "NSE") (hereinafter together referred to as the "Stock Exchanges").
- 1.4 In addition to the regulations/statutes referred to in paragraph 1.1 above, the Buyback is also in accordance with the Companies (Management and Administration) Rules, 2014, to the extent applicable and the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended. Eligible Shareholders also have the option of tendering additional shares (over and above their entitlement) and participate in the shortfall created due to nonparticipation of some other Eligible Shareholders, if any. If the Buyback entitlement for any shareholder is not around number, then the fractional entitlement shall be ignored for computation of entitlement to tender Equity Shares in the Buyback.
- 11.9 The maximum tender under the Buyback by any Eligible Shareholder cannot exceed the number of Equity Shares held by the Eligible Shareholder as on the Record Date. In case the Eligible Shareholder holds Equity Shares through multiple demat accounts, the tender through a demat account cannot exceed the number of Equity Shares held in that demat account.
- 11.10 The Equity Shares tendered as per the entitlement by the Eligible Shareholder as well as additional Equity Shares tendered, if any, will be accepted as per the procedure laid down in the Buyback Regulations. The settlement of the tenders under the Buyback will be done using the "Mechanism for acquisition of shares through Stock Exchange" notified under the SEBI Circulars. Eligible Shareholders will receive a letter of offer along with atender/offer form indicating their respective entitlement for participating in the Buyback.
- 11.11 Small Shareholders holdings of multiple demat accounts would be clubbed together for identification of small shareholder if sequence of Permanent Account Number for all holders is matching. - 11.12 Participation in the Buyback by shareholders may trigger taxation in India and in their country of residence. - 2. PROCESS AND METHODOLOGY FOR THE BUYBACK

- 11. RECORD DATE AND SHAREHOLDER'S ENTITLEMENT
- 11.1 As required under the Buyback Regulations, the Company has fixed Friday, April 03, 2020 as the Record Date for the purpose of determining the entitlement and the names of the equity shareholders who are eligible to participate in the Buyback.
