Amidst incessant rains in district, district administration advises citizens no to go out unless absolutely necessary

- Deputy Chief Minister reviewed flood situation
- 10 people were washed away recently in Nagpur district
- District administration in a state of 'high alert'; Orange alert issued by Meteorological Department
- Guided commuters asked not to rush across overflowing rivers
- Stranded issued to commence crop and infrastructure damage survey as soon as rainfall stops
- Instructions given to evacuate citizens to safe places as per requirement
- Discharge commenced from a total of 18 dams in district
- Gates of Navegaon Khairi, Vadgaon, Nanda dams opened
- Order for all administration employees not to leave their headquarters

Nagpur 15 July: It has been raining incessantly in Nagpur district since the last few days and all the dams in the district are accumulating a huge amount of water. Water is being released from 18 dams of the district. The district administration has appealed to the citizens not to step out of their homes unless it is absolutely necessary. Ten people have died due to drowning in the water recently. Deputy Chief Minister Devendra Fadnavis took stock of the situation in the district with the District Magistrate. District Magistrate R. Vimla convened a press conference in this regard recently and appealed to the citizens to be vigilant. In the afternoon, the District Collector visited the flood affected areas of the district. The District Magistrate directly inspected the spillway in Nand Dam, Rama Dam and contacted the officials.

Meanwhile, Deputy Chief Minister Devendra Fadnavis contacted the District Magistrate and inquired about the flood situation in the district. She expressed grief over the incident at Nand Gomukh yesterday and directed to search for the missing people. She has ordered to give information about all the water bodies in the district and their release in the villages on the banks of the river. She has also clarified that there is a possibility of heavy rain in Nagpur district in the next few hours and all systems should remain alert. Nagpur district has received 91.90 mm of rain in the last 24 hours. The district has received about 357 mm of rain till July 12. This rainfall is above average. Therefore 13 medium dams in the district are 65 percent full. Three of these projects are 100% complete. In such a situation, the District

Collector has appealed to the citizens not to come out of their homes unless it is necessary. Due to heavy rains, water was flowing over the bridge at Nand Gomukh in Savanertaluka. A Scorpio vehicle passing by got stuck in the flood, which swept away six people and died. One person was also washed away in Pataka Kheri Nala in Saoner taluka. Yogesh Raut, 33, got washed away in the Sainagar drain of Mankapur near Nagpur city. Apart from this, one person died after drowning in Chikhali lake in Sapur of Katol taluka. A 39-year-old man, Dattu Madhukar Rajurkar, was washed away at Mauja Peth in Katol taluka on Wednesday. In this way, in the recent past itself, there have been reports of ten people being killed in different accidents. The Meteorological Department has predicted more heavy rains for the

next three days and the district and municipal administration has clarified that the safest way to deal with the situation is to go out of the house. According to the data received by the district administration, 20 people have died in various incidents from June 1 to July 13 due to this rain. 19 people have been injured, 88 animals have also been killed and 293 houses have been damaged. During the same month, the crop in 2 thousand 399 hectares has been ruined due to rain. The District Magistrate has ordered the survey as soon as possible and asked to provide immediate help. In the flood-hit villages, instructions have been given to take citizens to

safer places if needed and health arrangements have also been prepared. Snake bite medicine measures have been taken in every taluka. Citizens are requested to immediately contact the Taluka Health Center Sub-Centre. The District Magistrate has appealed to the citizens to contact the Taluka Control Room to get help in such a situation. Regarding the schools in rural areas, the decision will be taken after discussing with the Chief Executive Officer. Meanwhile, it has been requested that no officer-employee of the district administration should go out of the headquarters and the administration has continued the 24-hour contact system.

for treatment. He told that 15 days ago, cochlear implant surgery of 6 deaf and deaf children was successfully done. These include Sarvi Nikhare, Viraj Shinde, Priyanshu Lirade, Viraj Amle, Devansh Borkar, Ariba Sayyed. Its operation costs up to Rs 6 lakh. So poor people are not able to get the operation done. In such a situation, the facility of conducting free operation

has been provided under the ADIP scheme of the Central Government. Dr. Bedi says that after the operation, the child starts behaving like normal children. There are no difficulties in his life. He said that there is a need to create awareness among people about cochlear implant surgery. Cochlear implant is an electronic device. It directly affects the inner nerves of the ear.

Incessant rainfalls causing immense hardship to citizens



Nagpur 15 July: It has been raining heavily for the past one week. Every day, sometimes at night and sometimes in the day, even if it is raining for an hour or so, but due to this the whole city is suffering. In many

low-lying settlements, water is entering homes due to the overflowing of rivers and streams and choked drainage systems. Now the residents of the city are only wishing that this calamity should end soon. Even on Thursday, the process of light and sometimes heavy rain continued since morning. In between, the sun was also seen 1-2 times but for a few minutes. In the afternoon, it rained so heavily that many roads were waterlogged, and the streets became rivers. Water accumulated at many places under the RUB. The Meteorological Department recorded 52 mm of rain in the city till 5.30 pm. Even after that, it rained intermittently. In this season, 458 mm of rain has been recorded in the district from June 1 to the morning of July 14. Ambazari, Gorewada ponds have overflowed in the city. The water level of Futala has become very high. Other ponds have also started filling water on a large scale.
