Sub: Grant of Restricted Stock Units (“RSUs”) under Quess Stock Ownership Plan- 2020 (“QSOP 2020”)

We wish to inform you that the Nomination and Remuneration Committee of the Company has considered and approved the grant of RSUs under QSOP 2020:

- Grant of total 234,638 RSUs at a face value of Rs.10/- per RSU with effect from today to eligible employees, which should vest not earlier than 1 (One) year and not later than 6 (Six) years from the date of grant of RSUs.
- The allotment of shares against each RSU will be based on performance parameters and terms and conditions of QSOP 2020.
