Further to our intimation to the Stock Exchanges dated 3rd November, 2023 and pursuant to Regulation 30 of the SEBI (LODR) Regulations, 2015, relating to the fire incident which occurred on Friday, 3rd November, 2023 at around 10.15 AM at Company's Mahad plant situated at K-4/1, Mahad Industrial Area, Mahad, Maharashtra. Till date there have been seven casualties and the Company's first priority as of now is to take care of the safety and well-being of the impacted employees and their family. Company team is working & co-operating with the state and local authorities to restore normalcy in the said unit. The statutory compliances for the said incident will be followed as per the applicable law. The cause of fire is being investigated and the Company is committed to extend all assistance to the relevant authorities investigating into this matter.
