I, CS Shivaram Bhat have conducted the review of the compliance of the applicable statutory provisions and the adherence to good corporate practices by **ZUARI AGRO CHEMICALS LIMITED** (hereinafter referred as 'the listed entity'), having its Registered Office at Jai Kisaan Bhawan, Zuarinagar, Goa- 403726.
