Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulation, 2015, we hereby report the following:

I. Cessation of tenure of Shri Rajiv Sharma as Chairman Managing Director on the Board of Power Finance Corporation Limited

Reason for change	Pursuant to communication of Ministry of Power, Government of India, vide order No. 8/2/2015-PFC Desk dated 3rd October, 2016, Shri Rajeev Sharma was appointed as Chairman and Managing Director on the Board of Power Finance Corporation Limited w.e.f. 1st October, 2016 for a period of five years from the date of assumption of charge of the post, or till the date of his superannuation i.e. 31.05.2020 or until further orders, whichever is earlier. On completion of the said tenure on 31st May, 2020, Shri Rajeev Sharma ceases to be the Chairman and Managing Director on the Board of Power Finance Corporation Ltd. w.e.f. 1st June, 2020.

II. In continuation of our letter dt. 29th May, 2020, it is informed that pursuant to Ministry of Power, Government of India order No. 24-8/1/2019-PFC(MoP) dated 7th April, 2020 and resolution passed by the Board of Directors in its meeting held on 29th May, 2020, Shri R. S. Dhillon has assumed the charge of Chairman and Managing Director w.e.f. 1st June, 2020 (FN).
