NEW DELHI: Around 100 Afghan Sikhs and Hindus want to come to India but are unable to as some family members are yet to receive e-visas from the government of India, a Sikh leader said on Saturday. President of Gurdwara Management Committee, Kabul, Gurnam Singh Rajwanshi, who was evacuated from Kabul with five of his family members on Friday, said his son is among those awaiting their e-visas. Around 28 of them are yet to receive visas. Thus, 100 are waiting as it is difficult for most Afghan Hindus and Sikhs to

Tur dal wastage: Goa Forward seeks probe

PANAJI: Goa Forward Party president and MLA Vijai Sardesai on Saturday demanded an independent investigation by central agencies into the wastage of 241 tonnes of tur dal, procured by the Civil Supplies Department for public distribution during the Covid pandemic in 2020. In a press conference in Panaji, Sardesai said he has written to Prime Minister Narendra Modi seeking an investigation and hoped action will be initiated.

Man wanted in Delhi violence arrested

NEW DELHI: A 38-year-old man wanted in the Jahangirpuri violence case was arrested in northwest Delhi on Saturday, police said. Sheikh Sikandar, a resident of Jahangirpuri, was absconding since the violence in April and a reward of ₹25,000 was declared on his arrest, a police official said. Sikandar is also named in a murder case filed at the Jahangirpuri police station earlier, the cop said.

Bhojpuri singer held with 21 kg cannabis

NEW DELHI: A Bhojpuri singer, who has sung more than 100 songs, was arrested in the national capital for peddling drugs, an official said Saturday. The accused singer, Vinay Sharma, was nabbed with 21.508 kgs of Ganja. Deputy commissioner of police (west) Ghanshyam Bansal said the staff of Narcotics Squad, West District, received specific information on August 10 that a peddler, Vinay, would come to Todapur Village, Shashtri Marg 1 Point, Inderpuri to meet someone. Subsequently, a police team trapped him near Todapur.

Hooch kills 7 in dry Bihar's Saran

SARAN: At least seven people have died over the last three days allegedly after consuming spurious liquor in Saran district of Bihar which is a dry state, a senior police officer said on Saturday. The incident occurred after 11 people died and several others fell ill after drinking hooch in the same district last week. "Seven people have so far died in Masudhi area since August 10. Villagers claim the deceased consumed spurious liquor. The exact cause can only be ascertained after getting post-mortem examination reports," superintendent of police Santosh Kumar said.

'Ostracised' man's last rites performed

GUWAHATI: The buried body of a villager was exhumed and cremated as per Hindu rituals by the authorities in Assam's Darrang as locals refused to help his family with cremation due to social ostracisation owing to his inter-caste marriage 27 years ago. Atul Sarma, a 50-something man residing at Patolsingpara, died on Tuesday but the villagers refused to help the family in the last rites, the deceased's wife claimed. "The villagers told us to complete the last rites ourselves. One of my husband's brothers came forward and as he was alone, he could manage to only bury the body and not cremate it," she said.

Assam Girl's death: 3 cops suspended

TEZPUR: Assam Chief Minister Himanta Biswa Sarma has suspended three senior police officers of Darrang district, including the superintendent of police (SP), after allegations of dereliction of duty were levelled against them in a case of a girl's unnatural death. He also ordered the formation of a special investigation team (SIT) to probe the case. The girl, 13, who reported ly worked as a domestic help, was allegedly found hanging inside a house in Dhula in June.

Congress puts its ear to the ground in Rajasthan

Faced with the challenge of factionalism ahead of the assembly election next year, the ruling Congress in Rajasthan is set to conduct a survey and has hired a data analysis firm for the purpose.

The aim is to get feedback from the ground. The state is due to go for poll in December 2023. The survey will be focused on the performance of the state government led by Ashok Gehlot as well as that of the party's legislators.

Besides, the party is keen to know the mood of the people regarding the leadership in the state. Rajasthan has alternated between the Congress and the BJP in the past five elections.

The party is busy with organisational elections these days which are expected to get over by the end of this month. A new team of officebearers from the block to the state level will take over, after which the party will start its poll preparations.

Hizb chief's son, wife of 'Bitta Karate' among 4 staffers sacked in Kashmir

The Jammu and Kashmir government on Saturday sacked four employees including son of Syed Salahuddin, the self-styled chief of banned terror group Hizbul Mujahideen, and the wife of a jailed separatist who was also involved in fatal attack on minority community members. All the four have been dismissed for allegedly having links with forces working against India and spreading malicious propaganda, officials said.

They have been dismissed under Article 311 of the Constitution which enables the government to sack its employees without any inquiry.

Syed Abdul Mueed, son of Salahuddin (Syed Mohd Yusuf) and Manager (Information and Technology) at the Commerce and Industries Department, is among the dismissed employees.

He is the third son of the Hizb chief to have been sacked from the government job. Syed Ahmed Shakeel and Shahid Yusuf were dis-

missed from service last year. According to the officials, Mueed has allegedly been found having a role in three terror attacks on the Jammu and Kashmir Entrepreneurship Development Institute (JKEDI) complex at Sempora in Pampore and his presence in the institution has led to increased sympathy with the

secessionist forces. Assabah-ul-Arjamand Khan, the wife of Farooq Ahmed Dar alias 'Bitta Karate' and a 2011-batch


