The Company has accepted his resignation and relieved him from his responsibilities with effect from close of working hours of September 08, 2023.

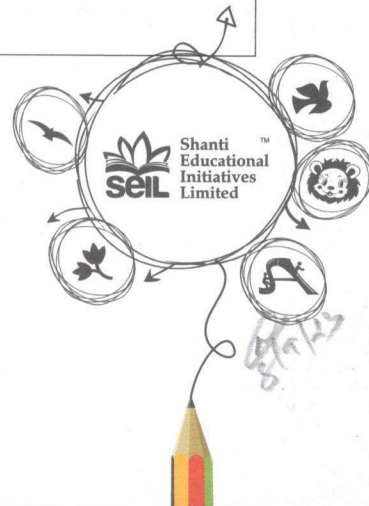


Sub: Resignation from the Position of Independent Director
