Ten Absent JJP MLAs Make Job Easier For BJP

Chandigarh: A day after dramatic events led to a change of guard in Haryana, newly appointed chief minister Nayab Singh Saini won the trust vote during a Haryana assembly special session on Wednesday, a task made easier by Dushyant Chautala. JJP's chief indirectly benefited BJP by asking his 10 MLAs to remain absent from proceedings, allowing BJP to easily sail

through the floor test with its own 41 MLAs. The backing of seven other members—six Independents and Gopal Kanda of Haryana Lokhit Party—came as additional support for BJP. However, a few other politicians, including Kiran Chaudhry of Congress, Abhay Chautala of

INLD and Independent MLA from Meham Balraj Kundu, left the House during voting. But JJP's whip to its MLAs remained the issue of discussion in the corridors of power.

On Wednesday morning, JJP chief whip Amarjeet Dhandu issued a whip stating, "All members of JJP in the Haryana legislative assembly are, therefore, requested to remain absent positively from the House at the time of voting on the confidence motion on Wednesday (sic)."

Five JJP MLAs were present in the assembly during the discussion, but all left before the floor test. Reports are emerging that these five MLAs have also kept their distance from Dushyant Chautala.

"This is the first time in the history of the country that a party has issued a whip to its MLAs to remain absent from the House. By doing so, JJP directly supported the confidence motion of BJP govt," said Congress's Bhupinder Singh Hooda, leader of opposition.

Hooda said that the purpose of breaking the alliance is also to help BJP in elections.

JJP will allot election tickets according to BJP so that anti-incumbency votes moving towards Congress can be divided, he said.

Court orders arrest of 2010 Bareilly riots mastermind: A fast-track court on Wednesday ordered Bareilly SSP to arrest the prime accused of 2010 riots case immediately. "Politician Tauqeer Raza Khan is a very influential person. Despite having a non-bailable warrant, police failed to arrest him. It appears law is different when it comes to influential people," it said. TNN

Meesho Kicks Off Esop Buyback Programme worth ₹200 crore

Bengaluru: Ecommerce firm Meesho on Wednesday announced an employee stock options (Esop) buyback programme worth ₹200 crore. The firm said this is their largest Esop buyback programme to date and would be open to both current and former employees. Meesho said it had conducted similar buybacks of \$1 million, \$5 million and \$5.5 million in February 2020, November 2020, and October 2021, respectively. The firm did not disclose which investors bought the stock options from employees. Around 1,700 former and current employees are eligible for the buyback, the firm said. Meesho currently employs 1,300 employees. The firm follows a four-year vesting period, with the first set of Esops getting vested after the completion of the first year. —Our Bureau

Paytm Races to Shift UPI Pay to 4 Banks

Bengaluru: Digital payments major Paytm is racing against time to migrate its banking services from Paytm Payments Bank to other lenders.

The National Payments Corporation of India, which runs the Unified Payments Interface railroad, is working to certify Paytm's application to become a third-party payment app, said two senior bankers in the know. Four banks — Yes Bank, Axis Bank, HDFC Bank and State Bank of India — will support Paytm's consumer-facing UPI payments, one of the bankers said.

The @Paytm UPI handle, which was issued by the payment bank to its customers through the Paytm app, might change after March 15, the bankers said. Paytm is run by listed firm One 97 Communications (OCL), which owns a 49% stake in Paytm Payments Bank (PPBL) and refers to it as an associate company.

"They will be issued fresh handles from the back-end and eventually customers will be migrated to each of the four banks in such a way that there is no extra pressure on any one entity," one of the bankers said. The Reserve Bank of India had asked Paytm Payments Bank to stop offering basic banking services after February 29, it later extended the deadline to March 15.

K'taka HC Extends Stay on Byju's EGM Resolutions

Bengaluru: The Karnataka High Court on Wednesday extended its interim stay on educational tech company Byju's plea challenging the validity of the extraordinary general meeting held last month that sought to remove founder Byju Ravendran as the chief executive officer.

The interim stay order, which turned the decisions of the EGM dated February 23 as non-enforceable, has been extended till March 28 — the next date of hearing. On February 21, Think and Learn, the Bengaluru-based edtech firm's parent entity, had approached the Karnataka High Court for a stay on the decision of the EGM, which was spearheaded by a group of investors.

Byju's claimed that the EGM was invalid as none of the founders attended the meeting and, as per the shareholder agreement, at least one founder needs to attend such a meeting for it to be valid. Think and Learn has moved court against investors Chan Zuckerberg Mauritius, General Atlantic, Prosus, Owl Ventures, Peak XV, Sands Capital, and T Rowe Price, who have been made respondents in this case.

Fintech SaaS Perfios becomes a Unicorn, Raises \$80 million

Ontario Teachers' Pension Plan's arm funds co

Bengaluru: Fintech-focused software startup Perfios has secured \$80 million from Teachers' Venture Growth (TVG), the late-stage venture and growth investment arm of Ontario Teachers' Pension Plan, the company said on Wednesday.

The funding round has catapulted Bengaluru-based Perfios to a billion dollars in valuation, making it the second company to achieve the unicorn status this year, after Bhavish Aggarwal's artificial intelligence startup Krutrim.

Perfios plans to utilise the funds to explore acquisitions and international expansion. The software-as-a-service startup will also invest in a tech stack to manage customer services across banking, insurance and embedded commerce.

TVG India director Darius Vakil is set to join Perfios' board as a nominee director. "Our business has been seeing steady growth year-on-year, with consistent improvement in the bottom line. This investment will further help us in strengthening the digital transformation journey of our partners, thereby powering financial inclusion and providing access to financial services to billions across the globe," CEO Sabyasachi Goswami said.

Bloomberg reported in January that the startup is considering an initial public offering to raise about \$500 million in India at a potential valuation of \$2 billion.

Battery Tech Startup Lohum Lands \$54 m at \$500 m Valuation

Singularity Growth Fund leads new raise

Bengaluru: Energy transition materials maker Lohum has raised ₹450 crore (\$54 million) in a primary funding round led by Mumbai-based Singularity Growth Fund, which counts CaratLane founder Mithun Sacheti among its backers. The funding happened at an about \$500 million valuation, people in the know said. Baring Private Equity, Cactus Venture Partners and VentureEast among others participated in the funding round. About 90% of the funding came in equity, with the rest 10% coming in venture debt from Stride Ventures.

Besides the ₹450 crore in primary funding, the firm also saw a secondary funding of ₹100 crore, Lohum founder and CEO Rajat Verma told ET in an interaction. "The firm will use the funds raised for market expansion in areas like North America, Europe, West Asia, Africa, and Asia, besides scaling up recycling operations in India." "We have seen the company evolve from just being a second-life company to a full-

scale material manufacturer; around materials like nickel, cobalt, and pre-CAM materials," said Yash Kela, chief investment officer, Singularity Growth Fund. "What impressed us was not just their ability to think globally from day one, but the fact that they have been able to expand into the entire battery lifecycle management with India as a node."

Lohum recycles batteries from electric vehicles (EVs) and other sources and produces battery grade materials like salts of lithium, cobalt, and nickel, which it then sells to firms in the battery manufacturing supply chain. It currently has a combined capacity of 4 gigawatt hours and employs 600 people, according to its website.

The firm is working on setting up a large integrated facility in Tamil Nadu, and is also setting up facilities in the UAE, the US, and Europe.

Nazara Technologies Sets Aside \$100 million for Acquisitions

Bengaluru: Mobile gaming and sports media company Nazara Technologies on Wednesday said it is setting aside about ₹300 crore, or \$100 million, for mergers and acquisitions in markets like India, Europe and North America. The investments will be made in larger cheque sizes ranging between ₹100 crore to ₹250 crore, and Nazara will either pick majority stakes in the target entities or invest with a clear path to majority holding, Nitish Mittersain, joint managing director and chief executive of Nazara Technologies, told ET in an interaction.

"We will strictly remain a strategic investor and not pick smaller stakes in firms," he said. He said Nazara is in advanced talks with two to three firms in the North American market in the game publishing sector without giving further details. In India, the firm is looking to acquire real money gaming firms and is in advanced talks with some, Mittersain said. He said the company has a total cash position of ₹1,500 crore, including funds from its various subsidiaries, from which it is earmarking this amount for buyouts. Over the past

few months, it raised ₹760 crore from a slew of investors including Zerodha cofounder Nikhil Kamath, SBI Mutual Fund, ICICI Prudential Mutual Fund and Plusus Wealth Management.

Nazara is targeting larger, mature businesses with strong revenues and profits for its investments, either in the game publishing sector or in adjacent sectors with robust intellectual properties (IPs), Mittersain said.

The firms should have a solid user base in North American markets, and ideally have users in markets like India too, he said. "North America is important to us as a scale-up market where we can drive monetisation, whereas India will be an important strategic market where we will take more long-term and smaller bets," he said.

Besides game publishing, Nazara will also look to make investments in sectors like gamified learning where it already has properties like Kiddopia, Mittersain said.

कैंसर की नकली दवा बेच बनाई करोड़ों की प्रॉपर्टी क्राइम ब्रांच खंगाल रही बैंक अकाउंट, शिकार हुए लोगों की भी तलाश

■ नई दिल्ली: कैंसर की नकली दवा बनाकर सिडिकेट ने करोड़ों रुपये की प्रॉपर्टी बना ली। दो साल से दिल्ली-पनसीआर के अलावा दूसरे राज्यों में महज 100 रुपये की दवाई भर कर एक से तीन लाख रुपये में बेचा गया। बिहार के मुजफ्फरपुर से आठवां आरोपी गिरफ्तार किया गया है। गंगा पर मकोका (महाराष्ट्र कंट्रोल ऑफ ऑर्गेनाइज्ड क्राइम एक्ट 1999) लागू किया गया है।

पुलिस सूत्रों ने बताया कि आरोपियों को रिमांड पर लेकर पूछताछ चल रही है। ये सिडिकेट करीब दो साल से कोमोथेरेपी के लिए इस्तेमाल होने वाली नकली दवा को बेचने का धंधा कर रहा था। दिल्ली में बाहरी राज्यों और विदेश से इलाज कराने वाले इनके टारगेट पर रहते थे। ठगी का शिकार हुए लोगों का भी पता लगाया जा रहा है।

पुलिस का दावा है कि अभी तक नकली दवा से कमाई कर चार फ्लॉट और एक फ्लैट खरीदने का पता चला है। इनकी कोमत करोड़ों रुपये में है। अभी और प्रॉपर्टी मिल सकती है, इसलिए पूरे मामले को विस्तार से जांच की जा रही है। इनके एक दर्जन से ज्यादा बैंक खातों का भी पता चला है। इनकी डिटेल्स के बारे में बैंकों को लिखा गया है।

खालिद की चुनौती पर हाई कोर्ट का पुलिस को नोटिस

■ विस, नई दिल्ली: जेएनयू स्कॉलर उमर खालिद ने अपने ऊपर गोली चलाने के मामले में आरोपियों को हत्या की कोशिश के आरोप से आजाद किए जाने को दिल्ली हाई कोर्ट में चुनौती दी है। कोर्ट ने खालिद की याचिका पर दिल्ली पुलिस से जवाब मांगा है। घटना 2018 में कॉन्स्टिट्यूशन क्लब के बाहर हुई थी। खालिद ने दो लोगों को आरोप मुक्त करने से जुड़े जिला अदालत के आदेश को चुनौती दी है। जस्टिस अनूप कुमार भेंदोरता ने पटियाला हाउस कोर्ट के एक एडिशनल चीफ मैट्रोपोलिटन मैजिस्ट्रेट के छह दिसंबर, 2023 के आदेश को चुनौती देने वाली खालिद की याचिका पर पुलिस और आरोपी व्यक्ति-दरवेश और नवीन दलाल को नोटिस जारी किए। इस मामले में अगली सुनवाई अब 21 मई को होगी।

मनीष सिसोदिया की हिरासत 22 मार्च तक बढ़ी

■ विस, नई दिल्ली: राज उषेन्यु की एक विशेष अदालत ने दिल्ली आवकारी नौति में कथित घोटाले से जुड़े भ्रष्टाचार के एक मामले में जेल में बंद पूर्व उप-मुख्यमंत्री मनीष सिसोदिया की न्यायिक हिरासत मंगलवार को बढ़ा दी। उन्हें स्पेशल जज एम. के. नागपाल के सामने पेश किया गया, जिन्होंने हिरासत की अवधि 22 मार्च तक के लिए बढ़ा दी। सीबीआई ने अदालत से कहा कि जांच अहम मोड़ पर है और अगर आप नेता को जमानत पर रिहा किया गया तो वह जांच में बाधा डाल सकते हैं या न्याय की जड़ से भाग सकते हैं। इस बीच अदालत ने उस अर्जी पर भी दलीलें सुनीं, जिसमें आरोप तय करने को लेकर शुरू की गई वकालत पर मामले के कुछ आरोपियों ने आपत्ति जताई है।

थी। शाम को घुड़चढ़ी हो रही थी। इसी दौरान भीड़ में से एक युवक आया, जिसने नोटों की माला तोड़ ली।
