# HAL may fly higher on GE deal, F&O inclusion

Rallies 29% in 7 days; analysts say firm well placed to execute order book

Mumbai, 27 August

hares of Hindustan Aeronautics (HAL) have been hitting new 52-week highs ever since news broke of the aerospace major signing a \$716-million deal with GE Aviation for supply of engines. The stock's inclusion in the futures and options (F&O) segment has also fueled the rally.

On Friday, HAL's stock hit a new one-year high of ₹1,398.10 intraday, before closing at ₹1,381.10 on the BSE Sensex, up 7.2 per cent over the previous day. It's all-time high, on intraday basis, is ₹1,424 made on August 14, 2020.

In the past seven trading days, the market price of HAL has swelled over 29 per cent after the company signed the deal with GE Aviation for procurement of 99 engines for manufacturing 83 Tejas Light Combat Aircraft (LCA) for Indian Air Force (IAF).

While the company clarified to exchanges on August 20 regarding the GE deal, it had on February 3 already informed exchanges that the government had formally sealed the deal of around ₹48,000 crore for procuring 73 indigenous LCA Teias Mk-1A fighter aircraft and 10 LCA Tejas Mk-1 trainer aircraft from

The company is also sufficiently placed in terms of cash, which the brokerage pegs at ₹7,000-8,000 crore in FY22 (net cash surplus).

In April, credit rating agency ICRA had upgraded the long-term rating of HAL with revised outlook to positive from stable, factoring in the significant improvement in business risk profile supported by new order inflows and significant collections from customers in FY21 resulting in negative net debt position at the end of last fiscal.

The ratings also positively factored in the expected buildup in the order book in FY22 with many large orders expected to be secured. The new order inflows provide high revenue visibility in the medium to long term, while also indicating HAL's strong competitive and strategic positioning. Brokerages peg the order book-to-bill ratio at over 5x based on FY22 projections.

# Looking to invest in a luxury property? Pin code is the key

Early entry in emerging destinations could fetch good returns, say experts

The real estate market has been reviving since the second wave of Covid-19 ebbed. The luxury segment, which had been somnolent for many years, has witnessed strong demand in recent months.

#### Location, location

The foremost factor that defines luxury is a coveted location. "Prized zip codes are the key. In addition, privacy and seclusion, great views, high-end interior, and architecture that is in sync with international trends are aspects that define luxury," says Anupam Rastogi, cofounder and head of NRI sales at Square Yards.

The price benchmark for luxury varies from one city to another. "Luxury real estate is the top 5 per cent of a city's property market by value," says Vivek Rathi, directorresearch, Knight Frank. Adds Ritesh Mehta, senior director and head, west, residential services and developer initiatives, India, JLL: "While in Mumbai a luxury property could be termed as one selling for ₹75,000 per sq ft and above, it would be ₹45.000 per sq ft in Delhi, ₹35,000 per sq ft in Bengaluru, Chennai and Kolkata, and ₹30,000 per sq ft

in Pune and Hyderabad." Mumbai, which hosts the highest number of luxury developments, is witnessing robust growth. "The central and south Mumbai micromarkets, which were languishing for the past several years, have witnessed greater traction in recent months," says Rathi.

Demand is up in newer destinations as well. "Tier-II cities like Surat, Hyderabad, Jaipur, Chandigarh, and Kochi are also witnessing rising demand for luxury projects," says Mehta. And it's not just apartments, demand for villas and townhouses is also on the upswing. Desire for healthy living

Several factors are driving this revival in demand. "Homebuyers in the luxury segment have seen a rel-

Experts say luxury housing can be a good investment, provided you are patient. "The current uptick in demand is likely to continue. This segment has always been a safe and prudent investment over the long term, regardless of whether it is deployed for rent, resale or personal usage. These are high-value assets that have an excellent chance of price appreciation," says Rastogi. Mehta feels investing in the

be a good idea. "Evolving luxury micro-markets are a good investment option at this stage. Investing in tier-II cities, where the market is at a nascent stage currently, would be a smart move," he says.

#### Do the due diligence

Unless you are very knowledgeable, seek expert advice before making such a high-ticket investment. "Find a local expert who is well-versed with prices and new developments in that micro-market," says Rastogi. He also suggests doing the due diligence on hidden costs that unnecessarily drive prices up. "Do an exhaustive study of the location, project density, the amenities on demand, and the security features. Also, study the developer's reputation," says Rastogi.

Rathi advises selecting RERA-registered developments. "The property should be in a ready project. If it is an under-construction property, it should belong to a reputable developer with a good track record of delivery. And it must be RERA-registered," he says.
