#### SUMMARY OF PROCEEDINGS OF THE 55" ANNUAL GENERAL MEETING

The 55<sup>th</sup> Annual General Meeting (AGM) of the Members of **3P LAND HOLDINGS LIMITED** (the Company) held on Monday, 31<sup>st</sup> August, 2020 at 10:00 a.m. through Video Conference (VC) / Other Audio Visual Means (OAVM) without physical presence of the Members at a common Venue.

Mr. Gautam Nandkishore Jajodia, Chairman of the Board, Chaired the Meeting.

The Chairman informed that, the 55<sup>th</sup> Annual General Meeting of the Company was held through Video Conference (VC) / Other Audio Visual Means (OAVM) in Compliance with the MCA Circulars & SEBI Circular and the relevant provisions of the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the proceedings of this AGM was deemed to be conducted at the Registered Office of the Company namely Thergaon, Chinchwad, Pune - 411033 which was the deemed Venue of the AGM.

The Chairman ascertained that the requisite quorum was present, the Chairman called the Meeting to order.

Thereafter he requested, the Board Members of the Company who are also participating the AGM through Video Conference from their respective locations, identify themselves and the location from where they are participating. At the request of the Chairman, all the Directors attending the AGM from their respective locations introduced themselves to the Members. Three Directors of the Company attended the AGM and the Chairman stated that two directors could not attend the meeting due to their pre occupation.

Thereafter, the Chairman informed to the Members that, the Notice convening the Annual General Meeting, the Directors' Report and the Audited Accounts for the year ended 31<sup>st</sup> March, 2020 and the Auditor's Report thereon were taken as read.

Parikh and Associates, have not expressed any qualification, observation or comments on financial transactions or matters which have any adverse effect on the functioning of the Company, in their respective audit reports for the financial year ended on 31<sup>st</sup> March, 2020. - 2. Appointment of Director in place of Ms. Vasudha Jatia (DIN:06725426), who retires by rotation and being eligible, offers herself for reappointment.
- 3. Ratification of Appointment of Auditors and fixing their remuneration.

#### **Special Business:**

- 4. Consent to the subsisting contracts already entered/to be entered into with Related Party(ies).
- 5. Approval for providing of Guarantee(s), Inter-Corporate Deposit(s)/ Loan(s) to Bodies Corporate(s).
- 6. Appointment of Mr. Romie Shivhari Halan (DIN:02816976) as an Non Executive Independent Director.

He further informed that, since the remote e-voting was already concluded and Members had cast their vote. The Resolutions as set out in the Notice of AGM need not be proposed and seconded.
