**INDORE:** A 21-year-old groom died while the bride is critical after both of them allegedly consumed poison following an altercation between them during their wedding ceremony in Indore, Madhya Pradesh, on Tuesday, police said. The groom was declared dead at a hospital, while the

bride is battling for life. Assistant sub-inspector Ramzan Khan said the groom consumed poison and informed his bride, 20, about it during their marriage at an Arya Samaj temple because of an altercation. As soon as she came to know the groom had consumed poison, she also drank it.

### DKS plays...

Earlier, both Siddaramaiah and Shivakumar met Rahul Gandhi separately at his 10, Janpath residence in the morning. DKS met Rahul Gandhi after Siddaramaiah and the two leaders spent over 30-minutes each with the former party chief. He is also learnt to have talked on the phone to former party chief Sonia Gandhi, who is learnt to have told him to meet Kharge, the sources said.

The Karnataka PCC chief then met Kharge again and spent an hour with him for the second day in a row. Surjewala was also present at Kharge's residence at the time. In the meeting he was shown the number of MLAs who are backing Siddaramaiah. This made DKS harden his stand saying after the two-year power-sharing agreement, what is the guarantee that these very MLAs would not raise a clamor for Siddaramaiah to continue as CM.

As things threatened to get complicated, Kharge held a number of meetings with party leaders including Rahul Gandhi, Congress central observers, newly-elected MLAs and the two main contenders Shivakumar and Siddaramaiah. After wrapping up his talks with top leaders and in the belief that the deal has been finalised, Siddaramaiah was prepared to leave for Bengaluru where preparations were on for the swearing-in ceremony at the Sree Kanteerava Stadium. But he was asked to stay put in Delhi and the preparations for the swearing-in were hurriedly called off in Bengaluru.

Both leaders have been asked to be in Delhi and refrain from making any statements or overtures that may cause embarrassment to the party.

Meanwhile, late in the evening, DKS went into a huddle with his supporters in Delhi. Earlier, when the media button-holed him in a lift, DKS said all the claims on CM are 'bogus' and mere speculation. When asked if he would be the next CM, he smiled and said "what is the hurry. Have patience." At the end of the day packed with meetings and speculations, AICC general secretary in-charge for

Karnataka Randeep Surjewala said a decision on the new cabinet will be in place in the next 48-72 hours.

Addressing the media outside Kharge's 10 Rajaji Marg residence, Surjewala said the party chief has been authorised to appoint the leader of the legislature party and that is why deliberations are underway.

"It (the decision to name the CM) is a matter of today and tomorrow and we will have a leader of the legislature party. Within the next 48 to 72 hours, we will have a new cabinet in Karnataka and in the first cabinet meeting, we will implement the five Congress guarantees and begin the work of building grand Karnataka," Surjewala said.

Kharge, who has been authorised by the legislature party, will announce (the name of the leader) after holding due deliberations. Urging the media not to resort to speculation, he said whenever a decision is taken by the Congress president, we will be happy to inform you.

"I am only here to quash multiple rumours and hearsay...that are being played on multiple news channels. Please don't believe in it," Surjewala said.

"Stop listening to rumours being planted by the BJP which is frustrated by the decisive defeat in Karnataka. The Congress is committed to the welfare of each Kannadiga, the Congress is committed to fulfilling its five guarantees, the Congress is committed to implementing its agenda. The Congress is committed to giving a clean, transparent and responsible government," he said.

Later in a tweet, Surjewala said all Congress leaders have been advised not to issue statements on the leadership matter. "Any out of turn remarks made from here onwards will be treated as indiscipline and action taken accordingly."

In Karnataka, there were celebrations in the native village of Siddaramaiah and outside his Bengaluru residence on Wednesday amid reports in a section of the media that claimed that his name has been finalised for the post.

Not to be outdone, supporters of DKS held placards outside Kharge's residence demanding the CM post

be given to their leader.

Mir alleged that the "attacks" on May 9 were "pre-planned" by the PTI leadership as a consequence of Khan's arrest. "It is safe to say, like the TTP (Tehreek-i-Taliban Pakistan), the PTI is also taking up the role of a non-state actor," he added.

In a grim warning, Chief of Army Staff (COAS) General Asim Munir vowed on Wednesday that all those responsible for "bringing shame to the nation on the Black Day of May 9" will be brought to justice. Khan has said that the unrest caused over his recent arrest was a planned conspiracy to ban his party, the PTI. "I have evidence this was a planned conspiracy to have PTI banned," he said, adding, "My cadre never targeted 'fauj' or created unrest. Not even when I was removed as PM in April."

Advocate Prashant Bhushan, appearing for a petitioner, accused the Modi government of trying to protect Adani Group by claiming in a reply in Parliament that SEBI was probing the group since 2021, which Solicitor General Tushar Mehta sought to deny.

"They must state on record what happened to the investigation being carried since 2016. If Adani shares increase abnormally by 5,000% etc then alarm bells have to be rung. There are statements in Parliament in 2021," he argued.

Solicitor General Tushar Mehta responded to these contentions stating that SEBI has the wherewithal and was dealing with the issue. "You pick up something in 2016 and then connect it with Hindenburg Report... 2016 is something totally different and distinct. Minister had stated that SEBI is probing some companies with compliance regulation. This probe had commenced in 2020 and the minister's statement is not about the probe originating in 2016," the SG said.

# SC: Can't mechanically stay HC order acquitting accused

## Need to hear them, says apex court

PTI / NEW DELHI

The Supreme Court on Wednesday refused to stay the Rajasthan High Court order acquitting four men who were handed down death penalty by the trial court in the 2008 Jaipur serial blast case, saying it cannot pass an order for such "drastic action" mechanically without hearing those held not guilty.

A bench of Justices Abhay S Oka and Rajesh Bindal, however, stayed a direction passed in the March 29 judgment of the high court asking the state's DGP to order inquiry against the investigating officer and other police personnel involved in the case.

The bench, which refused to stay the high court verdict, imposed certain conditions and directed that the four people, who were acquitted, be released unless

wanted in any other case.

Attorney General R Venkataramani, appearing for the Rajasthan government along with senior advocate Manish Singhvi, urged the bench to stay the high court verdict, saying those acquitted were convicted and awarded death penalty for a serious crime.

Senior advocate Maninder Singh and advocate Aditya Jain, appearing for the family members of the victims, also sought a stay of the high court verdict.

The bench said it is not going to "mechanically stay" the high court's order and needed to hear those acquitted.

It directed all the four will surrender their passports and, if released from jail, they will register their appearance on a daily basis between 10 am and 12 noon before the Anti-Terror Squad police station in Jaipur.

### Quad Summit cancelled

Analysts and diplomats warn that fears of an unreliable and dysfunctional America will now be revived in Asia and the Pacific, where the United States has only recently started to build momentum in its efforts to counter Chinese influence, reports the New York Times.

"It will reinforce lingering doubts about U.S. staying power," said Hal Brands, a professor of global affairs at Johns Hopkins University. "And you can bet China will make hay of this — its message to countries in the region will be, 'You can't count on a country that can't even perform basic functions of governance.'" American officials have framed the cancellation as a postponement, arguing that the last-minute change does not reflect a flagging commitment, adds the NYT.

In November 2017, India, Japan, the US and Australia gave shape to the long-pending proposal of setting up the "Quad" to develop a new strategy to keep the critical sea routes in the Indo-Pacific free of any influence amid China's aggressive behaviour in the region. Prime Minister Albanese, however, said that his Indian counterpart would still travel next week to Australia despite the cancellation of the Quad leaders' meeting and he is looking forward to welcoming him.

The Australian premier was responding to a question on whether Prime Minister Modi will still come to Sydney. "Prime Minister Modi will be here next week for a bilateral meeting," Albanese told ABC Radio in Brisbane. Albanese also said he will attend the G20 meeting that will be held in New Delhi later this year.

## HC summons to Hindi daily, reporters on Gambhir's defamation suit; refuses to pass interim order

**NEW DELHI:** The Delhi High Court on Wednesday issued summons to a Hindi daily and its reporters on a plea by BJP MP Gautam Gambhir seeking directions to the media house to withdraw the alleged defamatory publications in which "false and slanderous" statements were made against him. The court, however, declined to pass an interim order on the petition "at this stage". As an interim relief, Gambhir sought a court order to the media house to immediately withdraw "defamatory" publications against him and to restrain it from making similar allegations during the pendency of the suit.

## AK Singh to be Delhi's new Services Secy

Senior IAS officer AK Singh will be Delhi's new Services Secretary, replacing Ashish More who was removed by the AAP dispensation last week within hours of the Supreme Court ruling that matters related to the transfer of bureaucrats serving in the city lies under the domain of the city's elected government.

More's removal had snowballed into a controversy with him allegedly refusing to comply with the order and allegedly going incommunicado. The government has now sent the file related to his removal to the LG office, a Delhi govt official said. AK Singh will be the new Services Secretary, the official said.
