As per Articles of Association of the Company, Mr. Dharmendra Agrawal, Whole-time Director & CEO of the Company was elected as the Chairman & occupied the Chair for the Meeting and welcomed all the members and directors and invitees present in the meeting through VC/OAVM.

CS Neha Singh, Company Secretary informed that the company is having total 1238 shareholders as on the cut-off date i.e. 20th September 2023, and needs 15 members to constitute the Quorum. However 24 (Twenty-four) members were present, therefore adequate quorum for the meeting was present. The Chairman then declared the meeting to be in order and then the proceedings of the meeting was commenced.

CS Neha Singh, Company Secretary took a roll call of the Directors and introduced other invitees.

The Notice of the Annual General Meeting is given on 37th Annual Report and with the consent of Members the Notice of AGM was hereby taken as read.

The Auditors Report on the Financial Statements of the Company is given by the Statutory Auditors M/s. Mahendra Badjatya & Co., Chartered Accountant, Indore and the Auditors Report does not contain any qualification or negative remarks.

The Secretarial Audit Report for Financial Year 2022-23 is given by M/s D.K. Jain & Co., Practicing Company Secretaries, Indore and the same forms part of Annual Report. The Secretarial Audit Report does not contain any qualification or adverse remarks and with the consent of the Members, the Secretarial Audit Report of the Company, was taken as read.

(IST) and has already been completed on Tuesday, 26th September, 2023 at 5.00 P.M. (IST) and e-voting at this AGM has already been commenced and will be available up to 15 minutes from the conclusion of this AGM. Those who have already casted their vote by remote e-voting shall not be entitled to vote again in this AGM by e-voting.

The Members, who are in the records of the Company as on the cut-off date i.e. 20th September 2023, shall only be entitled to participate in the voting process.

After that the Company Secretary placed before the meeting businesses as contained in the Notice one by one for consideration and approval of the members.
