The company engaged Central Depository Securities (India) Limited ("CDSL") as the service
provider for extending the facility of electronic voting to the shareholders of the company.
The service provider provided a system for recording the votes of the shareholders
electronically on all the items of business (both ordinary and special business) sought to be
transacted in the 26th Annual General meeting ("AGM") of the Company, which was held on

31st day of December, 2020. Central Depository Securities Limited ("CDSL") had set up evoting facility on their websites www.evotingindia.com. The company had uploaded all the items of the business to be transacted on the website of the Company and also on the website of service provider to facilitate their shareholders to cast their vote through e-voting.

- As on the cut-off date for dispatch of Notice of Annual General Meeting, there were 369 shareholders of the company. The notice of Annual General Meeting and circular for e-voting was sent through courier service to all shareholders. There were no incremental shareholders who became member after dispatch of notice.
- The notice sent both through physical form contained the detailed procedure to be followed by the shareholders who were desirous of casting their votes electronically as provided in the Rule 20(4)(iii)(a)to(c) of the Companies (Management and Administration) Amendment Rules, 2015.
- The cut-off date for the purpose of identifying the shareholders who were entitled to vote on the resolutions placed for the approval of the shareholders was 24.12.2020. The E-voting facility was kept open from 28th December, 2020 (09.00 A.M.) to 30th December, 2020 (05.00 P.M.).
- 5. Pursuant to Rule 20(4)(v) of Companies (Management and Administration) Amendment Rules,2015, the Company also released an advertisement, which was published 21 days before the date of Annual General Meeting in Financial Express, English Newspaper dated 09th December, 2020 and Jansatta, Hindi Newspaper dated 09th December, 2020. The Notice published in the Newspapers carried the required information as specified in the rule 20(4)(v)(a)to(h) of Companies (Management and Administration) Amendment Rules, 2015.
- The Chairman announced the poll at the Annual General Meeting for the shareholders who have attended the meeting and have not cast their earlier through remote e-voting.
- After the time fixed for voting through poll at Annual General Meeting venue, i.e. between 11:10 A.M. to 11:30 A.M., ballot boxes kept for polling were locked in my presence with due identification marks placed by me.
- The locked ballot boxes were subsequently opened in my presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by M/s Beetal Financial and Computer Services Private Limited, Registrar and Transfer Agents of the Company and the authorization/proxies lodged with the Company.
- On December 31, 2020 after the Annual General Meeting the votes cast through e-voting facility were duly unblocked by me as a scrutinizer in the presence of Mr. Yash Prakash and Ms. Apurwa Meghna who acted as the witness and are not in the employment of the
