## Toll Revenue for Q2FY20

Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) has remained flat at Rs. 2,678.8 mn in Q2FY20 against Rs. 2,685.5 mn in Q2FY19.

- ARRIL- Toll revenue received (excluding cars) in Q2FY20 has increased by approx 2.8% to Rs. 238.6 mn from Rs. 232.2 mn in Q2FY19.
- AJTL- Toll revenue received (excluding cars and state buses) in Q2FY20 has increased by approx 19.1% to Rs. 112.9 mn from Rs. 94.8 mn in Q2FY19.
- **BHTPL-** Toll revenue received in Q2FY20 has reduced by approx 0.4% to Rs. 313.9 mn from Rs. 315.3 mn in Q2FY19.
- **HYTPL-** Toll revenue received in Q2FY20 has increased by approx 3.9% to Rs. 177.4 mn from Rs. 170.7 mn in Q2FY19.
- **MBCPNL-**Toll revenue received in Q2FY20 has reduced by approx 8.1% to Rs. 527.2 mn from Rs. 573.9 mn in Q2FY19.
- **DPTL-** Toll revenue received in Q2FY20 has reduced by approx 1.4% to Rs. 476.9 mn from Rs. 483.6 mn in Q2FY19.
- **RPTPL-** Toll revenue received in Q2FY20 has reduced by approx 20.7% to Rs. 209.6 mn from Rs. 264.3 mn in Q2FY19.
- **SUTPL-** Toll revenue received in Q2FY20 has increased by approx 12.2% to Rs. 314.6 mn from Rs. 280.4 mn in Q2FY19.
