“RESOLVED THAT pursuant to Sections 23, 42, 62 and other applicable provisions of the Companies Act, 2013 and the applicable rules made thereunder (including the Companies (Prospectus and Allotment of Securities) Rules, 2014 and the Companies (Share Capital and Debentures) Rules, 2014), each including any amendment(s), statutory modification(s), or re-enactment(s) thereof for the time being in force and in accordance with the provisions of the memorandum of association and articles of association of the Company, the Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (**“SEBI ICDR Regulations”**), the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and the Foreign Exchange Management Act, 1999 and the regulations made thereunder, including the Foreign Exchange Management (Non-debt Instruments) Rules, 2019, the Consolidated FDI Policy issued by the Department of Industrial Policy and Promotion, Ministry of Commerce and Industry, Government of India from time to time, each as amended; the listing agreements entered into by the Company with the stock exchanges where the equity shares of face value of ₹ 2 of the Company are listed (**“Stock Exchanges”**, and such equity shares, the **“Equity Shares”**); and any other provisions of applicable law (including all other applicable statutes, clarifications, rules, regulations, circulars, notifications, and guidelines issued by the Government of India (**“GOI”**), Ministry of Corporate Affairs (**“MCA”**), Reserve Bank of India (**“RBI”**), Securities and Exchange Board of India (**“SEBI”**), Stock Exchanges, and such other statutory / regulatory authorities), and subject to all approvals, permissions, consents, and / or sanctions as may be necessary or required from SEBI, the Stock Exchanges, RBI, MCA, GOI, or any other concerned statutory / regulatory authority, and subject to such terms, conditions, or modifications as may be prescribed or imposed while granting such approvals, permissions, consents, and / or sanctions by any of the aforesaid authorities, which may be agreed to by the board of directors of the Company (**“Board”**), which term shall include any committee which the Board of Directors may have constituted or may hereinafter constitute to exercise its powers, including the powers conferred by this resolution, approval of the members of the Company be and is hereby accorded to the Board and the Board be and is hereby authorised to offer, issue, and allot such number of Equity Shares to qualified institutional buyers (as defined under the SEBI ICDR Regulations whether they are holders of the Equity Shares or not, for cash, in one or more

tranches, for an aggregate consideration of up to Rs. 1,000 crore only (Rupees One Thousand Crore Only) (inclusive of such premium as may be fixed on such Equity Shares), through one or more qualified institutions placements (“QIP”), through the issuance of a preliminary placement document and a placement document, as permitted under applicable laws and regulations, at such price (including at a discount or premium to market price or prices permitted under applicable law), in such manner, and on such terms and conditions as may be deemed appropriate by the Board in its absolute discretion, considering the prevailing market conditions and / or other relevant factors, and wherever necessary, in consultation with the book running lead managers and / or other advisors appointed for the QIP.

RESOLVED FURTHER THAT in terms of the SEBI ICDR Regulations:

- (i) The allotment of the Equity Shares shall be completed within 365 days from the date of passing of this special resolution;
- (ii) The relevant date for the QIP shall be the date on which the Board decides to open said issue;
- (iii) No partly paid-up Equity Shares shall be issued / allotted;
- (iv) The issuance of the Equity Shares by way of the QIP shall be made at such price that is not less than the price determined in accordance with the pricing formula provided under Regulation 176(1) of the SEBI ICDR Regulations (“Floor Price”), and the price determined for the QIP shall be subject to appropriate adjustments as per the provisions of the SEBI ICDR Regulations, as may be applicable. It is clarified that qualified institutional buyers belonging to the same group or who are under same control shall be deemed to be a single allottee; and

RESOLVED FURTHER THAT the Equity Shares to be offered, issued, and allotted in terms of this resolution shall be subject to the provisions of the memorandum of association and articles of association of the Company and shall rank pari passu in all respects with the existing Equity Shares.

EXPLANATORY STATEMENT PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013

As required by Section 102 of the Companies Act, 2013, the following explanatory statement sets out all the material facts relating to the business mentioned.

Item No. 1

The Company anticipates growth opportunities in its operations and continues to evaluate various avenues for organic and inorganic growth. Accordingly, subject to compliance with applicable law, the Company proposes to raise capital for the purposes of pre-payment and / or repayment of our outstanding indebtedness, funding the long term growth of its existing businesses and capital expenditure of the Company, financing other long term capital, working capital, and general corporate requirements, and / or any other purposes, as may be permissible under applicable law and approved by the board of directors of the Company ("Board") / its duly constituted committee.
