I, Sumit Khanna Partner of M/s. Sark & Associates, Company Secretary, having its registered office at Unit No.215, Gundecha Industrial Estate, Akurli Road, Kandivali: - East, Mumbai: - 400101. have been appointed as a Scrutinizer of Vision Corporation Limited("the Company") for the purpose of scrutinizing the e-voting process in a fair and transparent manner as per the applicable provisions of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Voting through Poll on the below mentioned resolutions passed at the 27th Annual General Meeting of the Equity Shareholders of Vision Corporation Limited to be held on Friday 30th September, 2022 at 09:30 A.M at 2/A, 2nd Floor, Citi Mall, New Link Road, Andheri: West, Mumbai: 400053. - The period for e-voting remained open from 26th September, 2022 (09.00 A.M) to 28th September, 2022 (5.00 P.M).
- 2. The Shareholders holding shares as on the "cut-off" date i.e. 23rd September 2022 were entitled to vote on the proposed resolutions (item no. 1 to 6 as set out in the Notice of the 27th Annual General Meeting of Vision Corporation Limited).
- 3. The votes were unblocked on 29th September, 2022 around 06:00 P.M. in the presence of two witnesses, who are not in the employment of the Company. They have signed below in Confirmation of the votes being unblocked in their presence.
- 4. Thereafter, the details containing, inter-alia, list of equity shareholders, who voted "For" and "Against", were downloaded from the e-voting website of Central Depository Services (India) Limited (https://www.evotingindia.com/)

- 5. The Register, all other papers and relevant records relating to electronic voting shall remain in our safe custody until the Chairman considers, approves and signs the Minutes of the aforesaid Annual General Meeting and the same are handed over to the Authorized Person for safe keeping.
- After the closing of the poll by the Chairman, Ballot boxes kept for polling were locked in our presence with due identification marks placed by us.
- 7. The locked ballot box was subsequently opened in our presence and poll papers were diligently scrutinized. The poll papers were reconciled with the records maintained by the Company/Registrar and Transfer Agents of the Company.
- 8. The poll papers, which were incomplete and/or which were otherwise found defective have been treated as invalid and kept separately.
- The poll papers and all other relevant records relating were sealed and handed over to the Company Secretary/Director authorized by Board for safe keeping.
