Dear Sir/Madam,

This is to bring to your kind notice that, an Extremely Severe Cyclonic Storm "FANI" hit the Odisha Coast Friday, 3rd May, 2019 around 10:00 A.M. and continued its fury till evening. This Cyclone was most severe we faced in last 20 years. This Cyclone has caused severe damages to our office premises, office assets, trees has been fallen down, electricity poles are damaged and all business equipment's like our dish antenna's in the downlink centre / network operating centre in Bhubaneswar office is completely damaged as a result of which we are without electricity, water, internet, transport accommodation and signal till today also. We are running our offices on DG Sets. Especially in the city of Bhubaneswar links of internet not yet fully restored resulting our corporate office connectivity with all locations not yet settled down.

In view of the above we could not start audit work as per the schedule due to no electricity, transport, water, internet, accommodation etc. in our Bhubaneswar office for submission of financials for the quarter and year ended 31.03.2019.

We would like to bring into the notice of yourself that commencement of audit work for finalisation of financials is beyond the control of the Company and will start audit work once everything restored.

The company makes humble request to your good office to grant an extension for filing the financial results for the quarter and year ended 31.03.2019 upto 30th June, 2019 without levying penalty. This delay is inadvertent and beyond the control of the Company due to Extremely Severe Cyclonic Storm "FANI".

Keeping in view of circumstances as explained above, we further inform your good office that due to no connectivity, no electricity and problem in transportation/accommodation in Bhubaneswar city we could not inform you before. We hope that your good office shall consider our request favourably.
