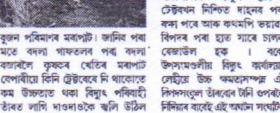

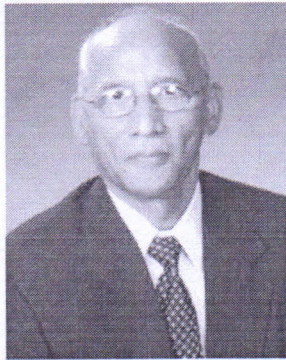

NFR recovers Rs 23 Cr. from ticket-less travelers

Guwahati, April 29: In a bid to keep a check on unauthorized traveling, the Northeast Frontier Railway (NFR) has been conducting regular ticket checking drives. With these intensive ticket checking drives, this Railway has detected 448,392 cases of passengers traveling without ticket/irregular ticket and unbooked luggage during the period from April 2021 to March 2022. An amount of Rs. 23.36 crores was realized from the offenders as fare and penalty. This is about 840.83% more in terms of numbers of penalty cases detected and 1028.50% higher in terms of earnings for the corresponding period of previous year.



Moreover during checking over various stations and train RPF of NFR apprehended 50,701 persons traveling without proper tickets from April 2021 to March 2022. In these cases 25 persons were also prosecuted and fined under various sections of Railways Act and 16 cases were registered against offenders. Northeast Frontier Railway regularly conducts drives against ticketless travelers. In its endeavour to provide better services to its bonafide rail users and also to curb ticketless traveling, NFR has regularly been taking necessary steps. NFR urges all rail users to buy proper railway tickets and travel with dignity. As per section 137, of the Indian Railway Act of 1989, traveling without ticket, improper ticket or unbooked luggage is an offense punishable by imprisonment or fine or both.

The Patient recovered within an hour, then the child and her parents went to the flight safely. On another day, in Guwahati Airport, a Passenger lost his wallet. However with the sincere efforts of the CISF Personnel the Passenger has got his wallet back. When A K Nath found the Purse he went directly to flight to deliver to the Passenger directly which was about to stop Boarding, but he insisted the flight attendants deliver the wallet to the Passenger. Again another day, an information was received by the Intelligence wing that a lady passenger informed CISF that she couldn't find her trolley bag at the arrival area and

exited from the terminal building. As per information received CISF team searched the arrival area through CCTV and noticed an unattended trolley bag left near the belt area beside the workstation. Immediately the lady was informed by CISF and she returned back to Airport to receive her bag and gave special thanks to the CISF staff, medical team at Guwahati LGBIA. Airport passenger informed the incident by email with their appreciation. The incident signifies the endeavor of LGBIA Airport to grow with goodness.

Bribe case: Food inspector caught red handed
