The Board Meeting commenced at 11:30 A.M. (I.S.T) and concluded at 2:00 P.M. (I.S.T).

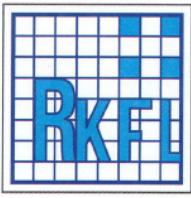

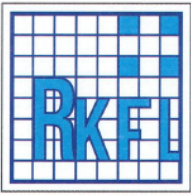
