- Sitting fees payable to directors who are IAS officers are deposited in Government Treasury Account.
- Deposit movement have been shown on net of basis. During the six month ended Sept.22 total deposit placed/renewed is Rs. 6,380.50 Crores and Total deposit withdrawn / redeemed Rs. 6023 Crores.
- The value of related party transaction as approved by the audit Committee represents an aggregate limit towards similar nature of transactions with different related parties. The reported transactions forms part of the aggregate limit.
