San Francisco, Aug 10 (IANS) Electric vehicle company Tesla CEO Elon Musk has sold 7.92 million shares of the company worth around \$6.88 billion, media reports say.

Musk's transactions occurred between August 5 and August 9, the US Securities and Exchange Commission (SEC) filings revealed, following Tesla's 2022 annual shareholder meeting on August 4 in Austin, Texas, reports CNBC.

Earlier this year, the tech billionaire said on social media that he had "no further Tesla sales planned" after April 28. That week, SEC filings revealed Musk had sold 7.92 million shares of the company worth around \$6.88 billion, media reports say.
