## Sub.: Post facto intimation of 2<sup>nd</sup> Meeting of Committee of Creditors (CoC) of Sintex Plastics Technology Limited which is currently undergoing Corporate Insolvency Resolution Process (CIRP)

- a. Replacement of IRP with another Resolution Professional (RP) and approval of fees of existing IRP till the approval of appointment of RP by Hon'ble NCLT.
- b. Ratification and approval of fees and other expense to be paid in connection with the appointment of Two Registered Valuers in accordance with Regulation 27 of the CIRP Regulations.
- c. Ratification and approval of fee and other related expenses to be paid in connection with the appointment of specialists for Transaction Audit u/s 43, 45, 50 and 66 of the Code
- d. Approval of calling the meeting of Committee of Creditors at a shorter notice in accordance with Regulation 19(2) of the CIRP Regulations
- e. Other regular matters related to the process.
