(MIP) is holding 22500 shares (before sub-division 4500 shares). However out of this, 500 shares (before sub-division 100 shares) have already been sold by MIP long back, however the same is still outstanding in its name. The aforesaid shares has been considered in their respective shareholding of the said entities mentioned in the given table.

(3) Steel Strips Ltd (SSL) has been amalgamated into SAB Industries Ltd. Therefore SSL does not exist as on date. However the name of SSL has been shown above because as per Company's member register SSL is holding 3000 shares (before sub-division 600 shares) whereas SSL has sold these shares long back and the purchaser did not lodge the same in his own name.
