Pursuant to SEBI Circular No. CIR/MRD/DP/18/2012 dated July 18, 2012, Circular nos. CIR/MRD/DP/04/2013 dated January 25, 2013, CIR/MRD/DP/17/2013 dated May 30, 2013, CIR/MRD/DP/24/2014 dated August 8, 2014, CIR/MRD/DP/32/2014 dated December 1 2014, along with further communication received from SEBI dated January 1, 2015, CIR/MRD/DP/12/2015 dated June 26, 2015, Circular no. CIR/MRD/DP/36/2016 dated February 15, 2016, Circular no. SEBI/HO/MRD/DOPI/CIR/P/2018/159 dated December 28, 2018 and Circular no. In order to comply with Minimum Public Shareholding norms, the offer for sale is being made by the promoter group of the Company i.e., Aditya Agarwal.
