Axis Mutual Fund ("Axis MF") is a mutual fund constituted in India and registered with the Securities and Exchange Board of India ("SEBI") under SEBI (Mutual Funds) Regulations, 1996 vide registration no. MF/061/09/02.

Axis Mutual Fund has disposed 0.16% equity shares of Mas Financial Services Limited (Target Company) on December 16, 2024, thereby reducing the holding to 3.02% of equity share capital.
