Dear Sir(s),

This is in continuation of our letter ref. no. FHL/SEC/2018-19 dated December 17, 2018 and letter dated November 18, 2019 in the matter titled "Vinay Prakash Singh v. Sameer Gehlaut & Ors." pending before Hon'ble Supreme Court of India ("**Court**"). Kindly be informed that Northern TK Venture Pte Ltd. (NTK) (promoter of the Company) through its legal counsel has today filed applications in the aforementioned proceedings seeking:

- (i) intervention in the Original Contempt (Civil) Petition no. 2120 filed by Daiichi Sankyo Co. Ltd ("**Daiichi**") arising under the Special Leave Petition (Civil) no. 20417/2017 filed by Daiichi, both before the Court and also in the *suo moto* contempt proceedings, inter alia, against the Company in relation to alleged violation of order dated December 14, 2018 ("**Order**") to enable NTK to be heard in the Court before any further orders are passed by it; and
- (ii) vacation of Order that continues to stay the mandatory open offer for acquisition by NTK, of up to 197,025,660 Company's shares representing additional 26% of Company's expanded voting share capital ("**Open Offer**") so as to enable NTK to consummate the Open Offer and support SEBI's ask of resuming the same.

We will keep the stock exchanges informed regarding material development in this matter. This is for your information and record please.
