Notes:

- 1 The audited financial statements for the quarter and year ended 31st March, 2021 are reviewed by the Audit Committee and taken on record by the Board of Directors in their meeting held on April 29th, 2021. The statutory auditors have expressed an unqualified audit opinion. The financial statements are prepared in accordance with Indian Accounting Standards (Ind-AS) as prescribed under section 133 of the Companies Act, 2013 read with the Rule 3 of the Companies (Indian Accounting Standards) Rules,2015 and Companies (Indian Accounting Standards) Amendment Rules,2016.
- 2 The Company primarily operates in single segment i.e. manufacturing of components for Automobiles. Hence, no separate segment disclosures as per Ind AS 108 "Operating Segments" have been presented.
- 3 The Board at his meeting held on April 29th, 2021 has recommended a dividend @ 25% i.e. Rs.1.25 per share (on fully paid up equity share of Rs. 5/- each) for the year ended 31st March 2021.
- 4 The figures of the previous periods have been re-grouped/re-classified, wherever necessary to conform to the current quarter's classification
- 5 The Consolidated financial results include the results of the Company and 1 Joint Venture .

- 6 The Company has considered the possible effects that may result from the pandemic relating to COVID-19 on the carrying amount of property, plant and equipment, Investments, Inventories, receivables and other current assets. In developing the assumptions relating to the possible future uncertainties in the global economic conditions because of this pandemic, the Company, as at the date of approval of these financial results has used internal and external sources on the expected future performance of the company. The Company has performed sensitivity analysis on the assumptions used and based on current estimates expects the carrying amount of these assets will be recovered. The impact of COVID-19 on the Company's financial results may differ from that estimated as at the date of approval of these financial statements.
- 7 The figures for the current quarter ended March 31, 2021 and quarter ended March 31, 2020 are the balancing figures between the audited figures in respect of the full financial year ended March 31, 2021 and March 31, 2020, respectively and published year to date figures up to third quarter ended December, 2020 and December, 2019, respectively which were subjected to limited review.
- 8 The Code on Social Security, 2020 ('Code') relating to employee benefits during employment and post employment benefits received Presidential assent in September 2020. The Code has been published in the Gazette of India. However, the date on which the Code will come into effect has not been notified. The Company will assess the impact of the Code when it comes into effect and will record any related impact in the period the Code becomes effective.

Report on the audit of the Standalone Financial Results

Opinion

We have audited the Standalone Financial Results of **Jay Bharat Maruti Limited** ("the Company") for the Quarter and Year ended March 31, 2021 included in the accompanying Statement of Standalone Audited Financial Results ("the Statement"), attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (the "Listing Regulations").

Opinion
