भले ही निर्भया जैसा जनाक्रोश नहीं जगा हो, लेकिन आम लोगों के साथ प्रधानमंत्री, राष्ट्रपति और मुख्यमंत्रियों की महिला अपराधों के खिलाफ सख्त कार्यवाही की मंशा यह जताती है कि वह समय अब दूर नहीं कि अपराधी के पाप को पीड़िता चुपचाप सहन करें आज समाज व सरकार महिलाओं को संरक्षण तथा न्याय देने के लिए सतत प्रयत्नशील है। यह भी सच है कि केवल सख्त कानून बना देने से ही अपराध पर अंकुश नहीं लगने वाला। यदि ऐसा होता तो 2012 में निर्भया कांड के बाद बने सख्त कानून के बावजूद महिला अपराधों की ऐसी तस्वीर सामने नहीं आती कि अबोध बालिकाओं के देह शोषण की घटनाएं हो। कानूनी प्रावधानों के साथ समाज में जागरूकता तथा अपराधियों को सजा दिलाने में सहयोगी बनने की जरूरत है । प्रधानमंत्री यह कह चुके है कि महिला अपराधों से निपटने के लिए सख्त कानून बने हुए है। जिन पर अमल करने की जरूरत है अर्थात कानून तो बने हुए है लेकिन पुलिस व अदालतों के साथ राज्य सरकारों से अपेक्षा है कि कानून प्रावधानों को लागू करके पीड़िताओं को न्याय दिलाने में अहम भूमिका निभाये फिर यह भी अपेक्षा रहती है कि ऐसे जघन्य मामलों में राजनीति नहीं की जाय। अपराध को राजनीतिक नजरिये से नहीं देखा जाय। या कानूनी प्रावधान लागू करने की बजाय राजनीतिक लाभ-हानि के अनुसार बयानबाजी की बजाय मानवीय दृष्टिकोण से पीड़िता को यथाशीघ्र न्याय दिलाने में सहयोग किया जाय। पं. बंगाल में डॉक्टर से दुष्कर्म व हत्या का मामला पूरे देश को झकझोर

आरजीकर मेडिकल कॉलेज की प्रशिक्षु महिला डॉक्टर का बलात्कार और हत्या के मद्देनजर पं. बंगाल विधानसभा के विशेष सत्र में पं. बंगाल सरकार ने सर्वसम्मति से सख्त अपराजिता महिला एवं बाल (पं. बंगाल आपराधिक कानून संशोधन) विधेयक 2024 सर्वसम्मति से पारित कर दिया। विधेयक को विपक्षी भाजपा सदस्यों के समर्थन से विधानसभा में पारित किया गया । जिसे अब प्रावधानों के तहत मामले की जांच 21 दिन में करनी होगी। इसके अलावा अगर दुष्कर्म पीड़िता कोमा में चली जाती है या उसकी मौत हो जाती है तो दोषी को दस दिन में फांसी का प्रावधान है। मुख्यमंत्री ममता बनर्जी ने इस विधेयक को ऐतिहासिक और पिछले महीने कोलकाता के आरजीकर मेडिकल कॉलेज एवं अस्पताल में दुष्कर्म के बाद मार डाली गई जूनियर डॉक्टर को श्रद्धांजलि बताया। उन्होंने कहा कि दुष्कर्म अब राष्ट्रीय शर्म बन गया है। आईये हम सामाजिक सुधार के लिए एक साथ आये, जो दुष्कर्म को रोकने के लिए जरूरी है । विधेयक में दुष्कर्म के दोषियों के लिए पैरोल के बिना आजीवन कारावास की भी सिफारिश की गई है। इसमें बेवजह एफआईआर लेने में देर करने, दर्ज नहीं करने या इरादतन विलंब करने और सबूत मिटाने वाले पुलिस अकधकारी को जेल की सजा के प्रावधान का सुझाव भी शामिल है। आवश्यकता इस बात की है कि अन्य राज्यों भी जहां आवश्यक हो कानूनी संशोधन करके कानून को सख्त तथा कठोर सजा के प्रावधान युक्त किया जाय।
