



We did not audit the financial statements of a wholly-owned subsidiary company, I&PCL Vacuum Cast Limited, whose financial results reflect total assets of Rs.#18.82 lacs as at 31<sup>st</sup> March, 2021 as well as total revenues of Nil and net loss after tax (including other comprehensive income) Rs. 5.82 lacs for the year ended on that date as considered in the consolidated financial results. Our report on the statement is not modified in respect of this matter with respect to our reliance on the work done and the reports of other auditors.
2. The Statement includes the results for the quarter ended March 31, 2021 being the balancing figure between the audited figures in respect of the full financial year ended March 31, 2021 and the published unaudited year-to-date figures up to the third quarter of the current financial year, which were subjected to a limited review by us, as required under the Listing Regulations.
