प्रेमवती इस बात को लेकर बिजनेस से नाराज थी कि दो अन्य भाइयों के होते हुए ननद के रिश्ते की जिम्मेदारी बिजनेस ने क्यों उठा रखी है। इसी बात को लेकर रविवार दिन में दोनों के बीच कहासूनी के बाद मारपीट भी हुई, जिसके बाद बिजनेस घर से चला गया पिति के व्यवहार से क्षब्ध प्रेमवती (36) ने रविवार रात गुस्से में अपने दोनों बेटों मोहित (8) व रोहित (5) को खाने में सल्फास मिलाकर खिलाया और फिर खुद भी निगल लिया। देर रात तीनों की हालत बिगड़ने लगी। बच्चों और प्रेमवती को उल्टी करते देख परिजन उन्हें बिसौली स्थित एक प्राइवेट अस्पताल ले गए, जहां डॉक्टरों ने उसके दोनों बच्चों को मृत घोषित कर दिया। गंभीर हालत में प्रेमवती को बरेली हायर सेंटर रेफर किया गया लेकिन रास्ते में उसकी भी मौत हो गई। घटना की जानकारी मिलते ही वजीरगंज और बिसौली थाने की पुलिस मौके पर पहुंची और सभी के शव को शवगृह में रखवा
