Stocks crash, rupee weakens, bonds steady

THE DOLLAR continued to gain as other currencies globally continued to weaken, after the 'risk on' sentiment took a hit amidst dwindling hopes of a quick economic recovery.

URBhat, director, Dalton Capital Advisors (India), said, "The recent dollar appreciation is the proximate reason for gold price correction because an appreciating dollar is seen as a safe haven to rush to. Equities, however, have a life of their own and with the fundamentals not supporting current valuations and foreign portfolio investor flows turning negative of late, markets are correcting."

The benchmarks have fallen by 6.07% since September 17. The strong sell-off was witnessed across the market and the Nifty had only three gainers for the day. Deepak Jasani, head - retail research of HDFC Securities, said investors have been bombarded with a perfect storm.

Markets had risen by 51% since their March 23 lows owing to the rush of liquidity in the markets after stimulus given by the central banks globally. This led to markets running ahead of the economic fundamentals.
