# Glaucoma eye disorder is expected to double in India by 2040

Chennai, Jan 27: Glaucoma refers to a group of eye disorders. Most commonly occurs when the pressure inside the eyes (intraocular pressure or IOP) increases enough to damage the optic nerves though it may occur in some cases when the pressure is normal. As the optic nerves that are responsible for sending images to the brain are affected, it results in vision loss. If left untreated, glaucoma can result in permanent blindness.

Talking about the signs and symptoms of glaucoma, Dr. Soosan Jacob, Associate Chief - Clinical Services, Dr. Agarwals Eye Hospital, Chennai said that they vary depending on the type and

early warning signs. The effect is so gradual that people may not notice any change in vision until the condition progresses to an advanced stage. Hence, the only way to find out if glaucoma is to get a comprehensive dilated eye exam.

According to Dr. Soosan Jacob, Dr. Agarwals Eye Hospitals, the risk factors include the increasing prevalence of chronic conditions like: Diabetes, Cardiovascular diseases, High blood pressure, Myopia, Family history

Those who are diabetic undergo treatments, for certain eye diseases, and those who use oral contraceptive pills for long periods are highly

susceptible to glaucoma. But glaucoma can affect people of all age groups and even those who do not have any chronic conditions or family history. It is diagnosed even in children.

Dr. Soosan Jacob said, Increasing awareness of the risk factors and symptoms of glaucoma should be an important strategy to address the growing glaucoma challenge. People should do regular periodic eye checkups at least once a year. Whether there are any symptoms or not, people with diabetes and other diseases are advised to undergo eye checkups compulsorily once every 6 months.

## Historical Research Center excavate inscription of 3000 years near Uthiramerur

Kancheepuram, Jan.27: The Uthiramerur Historical Research Center in an excavation near the Kurumpirai hill, near Salavakkam, next to Uthiramerur has dugout fossils of emeralds which have been used to bury the dead about 3000 years ago.

The inscriptions are a type of monumental belonged to the Paleolithic culture. According to the Center, the bodies of the dead are kept in large tombs under these stone circles and their favourite objects are kept and this was the beginning of the construction of tombs.

Further, the inscriptions reveal that human traces



are often found in mountainous areas and slopes.

The centre has dug out more than 10 inscriptions in a row on this cliff, each 5 meters long and 5 meters wide.

More than five boulders found adjacent to Edamichi Village, near Chinnamalai reveal that a large number of people have been living in the village during the stone age. Historians estimate that those inscriptions may have been dated back to 2500 to 3000 years which clearly defines the people who have been living in this town for about 3000 years ago.
