**Clarification /Confirmation on news item appearing in “Media/Publication”**

Please refer to your email dated January 30, 2023 on the captioned subject.  
In this connection, Bank’s clarification is as under:

IDBI Bank had earlier terminated all the rating contracts/ engagement with Moody’s Investor Services for various issues under the Bank’s MTN Bond Programme and had intimated the termination to the Stock Exchanges on December 26, 2017 (copy enclosed). However, Moody’s continued to carry out unsolicited rating so far without mentioning the same in their rating report. Now, Moody’s vide press release dated January 30, 2023 informed that they have withdrawn IDBI Bank’s rating for business reasons. The email from Moody’s was received by the Bank only on January 30, 2023. As the Bank had already terminated the services of Moody’s, the press release now from Moody’s will not have any material impact.
