महू। शहर से करीब चार किलोमीटर दूर तेलीखेड़ा स्थित उप जेल से रविवार सुबह करीब साढ़े दस बजे जब भोजनषाला में कैदियों को भोजन दिया जा रहा था, तभी मौका देखकर एक कैदी तकरीबन 14 फीट उंची दीवार फांद कर भाग निकला, सुबह से रात तक जेल

प्राासन ने उसे तलाश किया जब नहीं मिला तो रात्रि दस कर दी है। बजे के बाद कोतवाली पुलिस में भागे बंदी भेरूसिंह निवासी केशरवर्डी थाना बड़गोंदा व उसके साथी कैदी जगदीश पिता रमेश साठिया निवासी बड़नगर के खिलाफ विभिन्न धाराओं में प्रकरण दर्ज कर जांच शुरू

जांच जारी- उपर जेल से कैदी के रफूचक्कर होने के बाद से ही भोपाल - इंदौर तक हलचल है, इंदौर जेल अधीक्षक अलका सोनकर सोमवार को भी जेल परिसर पहुंची और मामलें में जेल प्रभारी के साथ ही मौके पर ड्यूटीरत जेल कर्मियों व अनेक बंदियों से पूछताछ की। जेल महानिरीक्षक के आदेष के बाद मुख्य प्रहरी मोहनसिंह बारिया व प्रहरी लखन निंगवाल को सस्पेंड कर दिया है। वही जेल परिसर में लगे सीसीटीवी कैमरों की मदद से पूरे घटनाक्रम की जांच की जा रही है, वही कोतवाली थाना प्रभारी संजय द्धिवेदी भी मौके पर पहुंचे और मामले की जांच -पड़ताल शुरू कर दी।



निजी स्कूलो में बढ़ती फीस एवं महंगी बुक मोनोपालिसी से हो रही लूट को लेकर

एसडीएम को सौंपा गया ज्ञापन

मह्। अखिल भारतीय ग्राहक पंचायत जिला इन्दौर द्वारा एसडीएम को ज्ञापन सौंपा गया। दरअसल पंचायत को अभिभावकों से इस आशय की शिकायतें प्राप्त हुई हैं कि जिले के निजी विद्यालयों द्वारा प्रकाशकों से सांठगांठ करके खलेआम विद्यार्थियों और अभिभावकों का शोषण किया जा रहा है। विद्यालयों द्वारा अभिभावकों को नियम विरुद्ध रूप से एनसीआरटी की पुस्तकों के स्थान पर निजी प्रकाशकों की पुस्तकें क्रय करने के लिए बाध्य किया जा रहा है, जिसके कारण अभिभावकों को छोटी-छोटी कक्षाओं के बच्चों के पाठयक्रम की पुस्तकें हजारों रुपयों में क्रय करना पड़ रही हैं।

विद्यालयों द्वारा अभिभावकों को अत्यधिक संख्या में पुस्तकें क्रय करने के लिए बाध्य किया जा रहा है, जिसके कारण छोटे-छोटे विद्यार्थियों के बस्तों का वजन शासन द्वारा निर्धारित वजन से बहुत अधिक हो गया है। इसके कारण अभिभावकों के मानसिक एवं आर्थिक शोषण के साथ-साथ बच्चों का मानसिक और शारीरिक शोषण हो रहा है और बच्चों का मानसिक व शारीरिक विकास बाधित हो रहा है। निजी विद्यालयों द्वारा अभिभावकों को विद्यार्थियों की डेस सामग्री निश्चित दुकान से ही खरीदने का दबाव बनाया जाता है जिससे इन तय दुकान द्वारा बाजार में एकाधिकार होने से मनमाने रेट पर डेस का विक्रय किया जा रहा है!

निजी विद्यालयों द्वारा प्रत्येक वर्ष छात्रों की फीस को नियम विरुद्ध रूप से बढ़ाया जा रहा है, जिससे अभिभावकों की जेब पर अतिरिक्त आर्थिक बोझ बढ रहा है। शिक्षा विभाग द्वारा केवल खानापूर्ति के लिए इस सम्बन्ध में जाँच दल बनाये गये हैं जो सारी वास्तविकता

जानते हुए भी किसी भी विद्यालय के विरुद्ध कोई कार्यवाही नहीं कर रहे हैं। अतः अ.भा.ग्राहक पञ्चायत जिला इन्दौर इस ज्ञापन के माध्यम से आपसे माँग करती है कि विद्यालयों द्वारा किये जा रहे इस शोषण को रोकने के लिए सच्चाई सामने लाने हेतु शिक्षा विभाग द्वारा बनाये गये जाँच दलों में ग्राहक पञ्चायत के कार्यकताओं को भी सम्मिलित किया जाए और शोषण करने वाले विद्यालयों, प्रकाशकों और विक्रेताओं के विरुद्ध कठोरतम कार्यवाही करने का कष्ट करें।

यह ज्ञापन ग्राहक पंचायत के प्रांत संगठन मंत्री मुकेश कौशल के नेतृत्व में दिया गया। इस अवसर पर मुख्य रूप दीपक वर्मा, रवि धीमान ,राजेश बोरासी . सुरेश परिहार .धर्मेन्द्र कलमे. नन्दु वर्मा ,नवीन पंवार , राजकुमार कौशल नवीन इंचुरकर जोनी इंचुरकर हरीश सोडानी साहिल यादव आदि उपस्थित रहे।

जेल - ब्रेक

मह्। तकरीबन तीन दशक पूर्व शुरू हुई तेलीखेड़ा उपजेल एक बार फिर चर्चाओं में है। दरअसल रविवार को रेप केस के आरोपी ने साथी की मदद से उंची - उंची दीवारें फांद दी, इस लापरवाही पर प्रारंभिक एक्षन लेते हुए दो जेल कर्मचारियों को निलंबित भी कर दिया गया है, वहीं मामले की जांच के साथ ही जेल प्रभारी मनोज चैरसिया की भूमिका व घटना आदि को लेकर बयानबाजी जारी है। इधर उपजेल में हुए घटनाक्रम के बाद बंद कैदियों के अनेक परिजन यहां पहुंचे, हालांकि बंदी के फरार हो जाने व जेल अधीक्षक आदि मौका - मुआयना के चलते उनकी मुलाकातें नहीं हो सकी। इधर उपजेल में बंद बंदियों के परिजनों व मिलने - जुलने वालों ने दबी जुबान से जेल प्रबंधन पर आरोप - प्रत्यारोप लगाए जो खासे हैरान कर देने वाले है, साथ ही रसूखदार या फिर मांग - पूर्ती? के चलते कैदियों को विशेष सुविधा यहां तक शराब - व्यसन आदि को लेकर भी दावे - प्रतिदावों के बीच बहुत कुछ सुनाई दिया। इधर 2007 में जेल में बंद कुख्यात बदमाश जीतू ठाकुर की परिसर के अंदर हत्या के बाद अनेकों ऐसे मामले आए जब उपजेल को लेकर चौक -चौराहों, सार्वजनिक स्थानों पर पक्ष - विपक्ष, बहस के बीच हैरतभरा बहुत कुछ सुनाई दिया। कोरोना काल में लोकायुक्त पुलिस ने रंगे हाथों जेल कर्मचारी व अन्य को रिवत लेते पकड़ा था तो एक समय बंद गैंगस्टर मांगीलाल ठाकुर की गिकायतों के चलते मुख्यालय से छापामार कार्रवाई की खबर थी, वही इंदौर के उद्योगपित हत्या के आरोप में बंद हेमंत नेमा, व उनके पुत्र सहित अन्य आरापियों की मेल - मुलाकात के सीसीटीवी फुटेज, धोखाधड़ी में बंद रहे मानपुर के व्यापारी शारडा, बंडा बस्ती हत्याकांड के आरोपी, जमीन जादूगर अरविंद बंजारी, इंदौर बदम्गा शाकिर चाचा, कुख्यात बदमाश हेमंत लुनिया, राशन घोटाले आदि को

लेकर बाहर तक चौकाने वाले चर्चाएं रही है, जबिक इस उपजेल को विशेष जांच याने की मुख्यालय व सुपरविजन अधिकारी की निगाहबानी में रखा गया है। अनेक बार मियादी व हवालाती बंदियों के परिवार ने भोजन आदि के साथ ही परिसर के अंदर वसूली के लिए बुरी मारपीट जैसे संगीन आरोप विभागीय के साथ ही अनेक मामले अदालत तक भी पहुंचे हालांकि अधिकांश मामलों में जांच पड़ताल के दौरान जेल प्रबंधन दोषी नहीं पाया गया। कुछ समय पूर्व एक जेल प्रहरी पांच -पांच सौ के नोटों का बंडल परिसर स्थित आवास में गिनते हुए स्ो्राल मीडिया पर वाइरल हुआ था, जबिक हाल ही में एक बंदी से जेलर व अन्य कर्मचारियों द्वारा मारपीट का सीसीटीवी विडियों बाहर आने के बाद पूर्व मुख्यमंत्री व राज्यसभा सदस्य ने अपने पत्र के साथ जांच की बात कही थी। जबिक करीब दो साल पूर्व विचाराधीन कैदी के संदिग्ध मौत के बाद परिजनों ने खासा हंगामा किया था, हालांकि उसकी मौत कथित बीमारी से होना पाई गई, खास बात यह है कि पूरा जेल परिसर सीसीटीवी कैमरे की जद में है, लेकिन अनेक ऐसे पाइंट है जहां तीसरी आंख की निगाहबानी नहीं है और ऐसे कई एंगल को लेकर जेल में बंद कैदी जमानत या रिहा होने के बाद आप बीती सुनाते रहे है, सूत्रों ने बताया पहले व दूसरे कार्यकाल इस तरह करीब छह साल पदस्थ जेल प्रभारी मनोज चैरसिया के कार्यकाल की सबसे ज्यादा गिकायतें हुई है, हालांकि श्री चैरसिया जेल प्रबंधन में कुशल है इसलिए मुख्यालय की भी पसंद बताए जाते हैं, उनका कहना है कि उनकी सख्ती के चलते ना सिर्फ जेल परिसर में अनुग्रासन है बल्कि बंद आरोपियों व मियादियों को तय मानक के अनुसार खुराक आदि भी मिलती है। इस मामले में और भी पक्ष - विपक्ष - आरोप - प्रत्यारोप लेकिन फिलहाल ब्रेक?
