SpiceJet finalises settlement with major lessor of MAX

aircraft

Hopes to see its MAX aircraft back in air soon, subject to regulatory approvals

Gurugram, **August 26**, **2021**: SpiceJet, India's favourite airline, today announced that it has entered into a settlement with Avolon, a major lessor of MAX aircraft, paving the way for the airline's 737 MAX aircraft to start to return to service.

The airline expects to start operations of MAX aircraft around the end of September 2021 subject to regulatory approvals.

As India emerges from Covid and air traffic picks up again, the MAX aircraft will play a major role in our future expansion.
