La Paz, the urban jungle!




La Paz, in Bolivia, is the highest administrative capital in the world, resting on the Andes' Altiplano plateau at more than 3,500m above sea level. It stretches to El Alto city in the highlands, with snow-capped, 6,438m-high Mt. Illimani as its backdrop. The city's dramatic setting can be taken in during rides on Mi Teleférico, the aerial cable car system.

Chacaltaya Ski Resort

This is the 5th


International Award for the Responsible Tourism Mission since its formation in 2017. The Mission has also won three National Awards.

British Council helps Indian students study in UK through virtual fairs

Chennai, Nov 7:

British Council is supporting students who are planning to pursue an education in the UK or are due to begin their education for January or September 2021. The last virtual fair was organised in September 2020 with representatives from 26 UK universities; over 2,300 students and parents attended the fair.

Janaka Pushpanathan, Director, South India, British Council said, "The Study UK virtual fair is likely to be held in December 2020, wherein students will have an opportunity to interact directly with university representatives and attend different seminars.

Attendees will be able to learn about scholarships, application processes, Student route, Graduate Route (from UKVI officers), and informative sessions on IELTS, studying and

living in the UK. British Council engagements include providing guidance and resources like pre-departure briefings, detailed information packs on studying in the UK, application admission guidelines and policies, access to UK higher education experts, knowledge sessions, latest responses (on COVID-19) by leading UK institutions for easy reference of students and live sessions by UKVI, UCAS and more. Scholarships There is a range of scholarships open to Indian students. Universities themselves provide many of these, but there are also government-funded scholarships. GREAT Scholarships 2021: announced on 26 October. There are 31 scholarships worth a minimum of £10,000 (each) towards tuition fees from UK universities for a one-year postgraduate course, across a variety of subjects for students from India. These are jointly funded by the UK government's GREAT Britain Campaign and the British Council with participating UK higher education institutions. According to the British Universities International Liaison Association (BUILA), individual UK Universities offer scholarships and bursaries worth over £13m to international students each year. The British Council administers over 40 Charles Wallace India Trust scholarships to mid-career professionals in the arts every year. The India Chevening country programme is the largest in the world and has supported more than 3,000 Indian scholars and fellows to come to the UK since 1983.

Understanding the correlation of heart failure and diabetic macular edema

Chennai, Nov 7:

Currently, India is considered as Diabetic Capital of World with 72 million people suffering from diabetes. Further, according to the World Health Organization (WHO), 98 million in India may have diabetes by 2030. On an average, Indians get diabetes 10 years earlier than other developing countries.

Diabetes is an illness that damages your body's ability to produce or use insulin. Recent studies indicate a strong correlation between Diabetes and Heart Failure (HF), DME (Diabetic macular edema) other chronic diseases.

Diabetes and Heart Failure

Diabetic cardiomyopathy can lead to Heart Failure, which is a progressive condition where the heart cannot pump enough blood around the body. People with Type 2 diabetes are 2.5 times more likely to develop congestive Heart Failure than those without the condition. Also, 25% of patients with chronic Heart Failure also have Type 2 diabetes.

Cardiovascular outcomes and hospitalization are worse for patients with diabetes relative to those without. This, therefore, raises the possibility that poor management of diabetes can lead to several health complications.

Dr. R Ravi Kumar, Senior Consultant and Associate Clinical lead Cardiology & Heart Failure Program, MGM Healthcare, Chennai, said, "Heart Failure is the leading cause of high death rates and repeated hospitalizations among other cardiovascular diseases. The mean age of Heart Failure patients in India is 59 years, which is 10 years younger than other countries. Diabetics often lack to identify the symptoms of Heart Failure as the symptoms might get subdued owing to their ongoing treatment of diabetes. If you are a Diabetic patient it is important to have a close check at the symptoms and keep going for regular check-up. Basis our hospital records, out of the total number of cardiac patients who visited the tertiary care center, 380 patients suffered from some degree of Heart failure out of which 75 were in an advanced stage of the disease."

It is important for diabetes patients to pay close consideration to symptoms like breathlessness, continuous tiredness and lethargy, unrestrained glucose levels and puffiness in the ankles, legs and abdomen. Diabetes should not confuse or ignore these symptoms as a result of their existing condition.

Diabetes and DME

Diabetic Macular Edema (DME) is the most common form of diabetic retinopathy (DR). It arises when the damaged blood vessels swell and outflow into the macula of the retina causing visibility issues in the normal vision. This is an important cause of vision loss in working age adults from (35-65 years). Every person living with diabetes is at risk of developing diabetic retinopathy. About 1 in 3 people living with diabetes have some degree of diabetic retinopathy and 1 in 10 will develop a vision threatening form of the disease.
