'Thudikkum Karangal' talks about a danger that surrounds today's youth" Vimal acted as a YouTuber. The film is set against the backdrop of

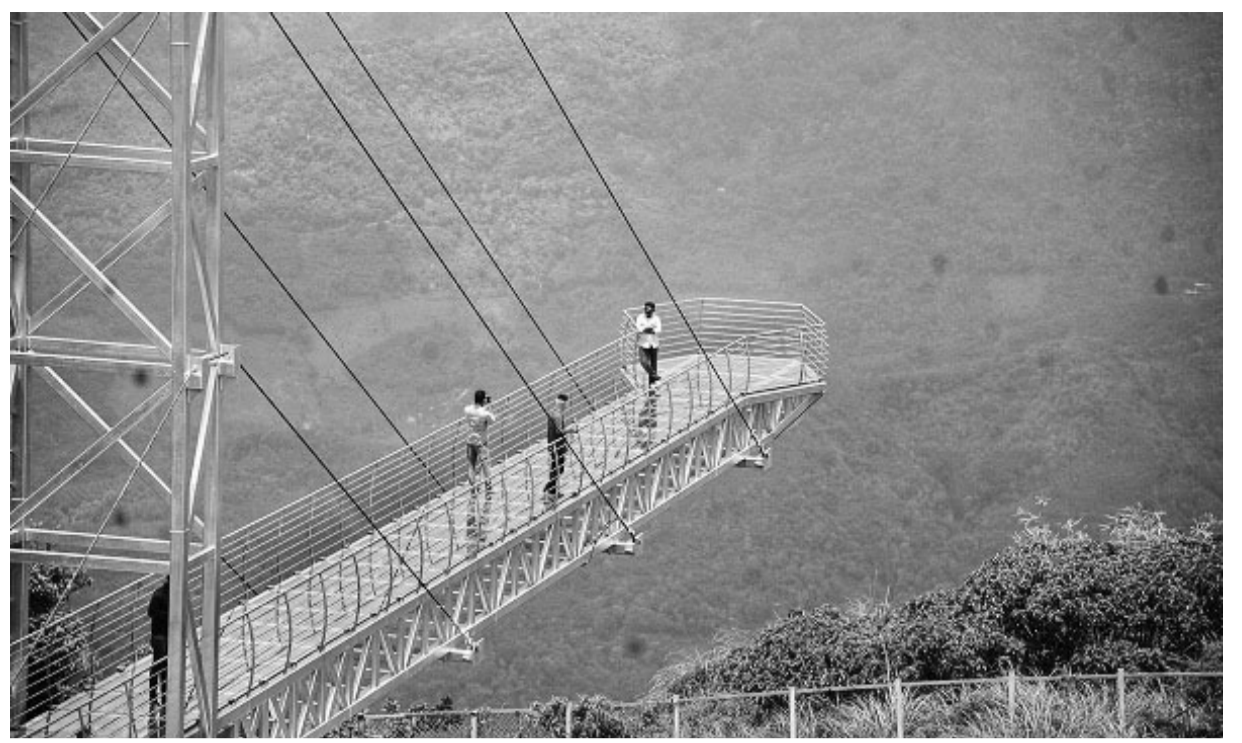
organised crime and the drug syndicate, as a killer is on the loose. The sneak peek promises a mix of thrill, romance and action in equal measures.

Vagamon glass bridge attracts more tourists to Idukki

Kumily, Aug 29: The newly-built cantilever glass bridge at Vagamon, which is the longest in India, and the heli-taxi service in Kumily are expected to attract a large number of tourists to Idukki this Onam season. District tourism promotion council (DTPC) officials said that the entry to the 40-metre long glass bridge set up at Vagamon

jointly by the DTPC and Perumbavoor-based Bharat Mata Ventures was thrown open to visitors on Saturday.

"The glass bridge that hangs on the mountain top at Vagamon Adventure Park has now overtaken the 26m-long glass bridge in Bihar to become the longest in the country. Apart from giving a top angle view of the 150ft-deep

valley below it, the glass bridge offers visitors a glance of far off place in Idukki and Kottayam," Nikhil P B, a representative of the private company which built the bridge said.

A five-layer 40mm glass imported from Germany is used for the bridge and the entire glass structure is supported with 35 tonnes of steel. The glass bridge

is hanging on six metal ropes connected to huge pillars made of steel on the mountain top.

The one-day heli-taxi service from Pathumuri helipad in Kumily will be conducted from 9am to 3pm on Sunday. The service organized by two private individuals will take the tourists by helicopter over the Vagamon region and to Munnar.

Cheetah safari to boost Kuno tourism

Madhya Pradesh, Aug 29: The government of Madhya Pradesh is planning a cheetah safari in the Saisaipura area of the Kuno National Park (KNP) to boost tourism and generate revenue, a forest official aware of the matter said on Friday.

The state has sent a proposal to the Central Zoo Authority and the National Tiger Conservation Authority (NTCA) for approval, said the official. "A

proposal has been sent to attract tourists and for the economic development of Saisaipura area. It will be developed in 150 hectares," KNP director Uttam Kumar Sharma said.

"The safari will have cheetahs who cannot survive in the wild and can be easily sighted by people," said a senior officer of the MP forest department.

So far, six adult cheetahs have died in Kuno since



the translocation of 20 big cats to India in two batches from Namibia and South Africa in September last year and February 2023, respectively. Besides, three of the four cubs born in India have also

died. The officer said that since it is difficult for tourists to see cheetahs at Kuno, we decided to start a safari. The safari will have two female cheetahs from Namibia, the officer added.
