

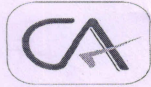

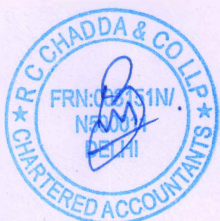
Opinion

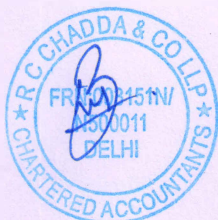
Key Audit Matters
