Centre defends scheme as protests break out in states

ADITI PHADNIS New Delhi, 16 June

As parts of India on Thursday reported violent protests against the proposed Agnipath recruitment system for the armed forces, political parties and former soldiers pleaded with the government to revise the scheme.

In Opposition-ruled states like Rajasthan and Bharatiya Janata Party (BJP)-governed Uttar Pradesh, Himachal Pradesh, and Haryana, the anger of unorganized groups of young people was evident.

Support Agniveers after tenure: FinMin to PSBs

NIKUNJ OHRI New Delhi, 16 June

The Union government has asked public-sector banks (PSBs), public-sector insurance companies, and other financial institutions to support Agniveers with employment and credit facilities on completion of their duty tenure.

PSBs, insurance companies and financial institutions to identify ways to support Agniveers on completion of their tenure of duty. To support Agniveers, banks would explore possibilities of providing credit facilities for skill upgradation, education, setting up businesses through various central government schemes such as MUDRA, Stand Up India, among others.

Almost all opposition political groups asked the government to review the procedure. While Bahujan Samaj Party (BSP) leader Mayawati asked the government to take back the recruitment system, senior Congress leader P Chidambaram said the scheme is "controversial, carries multiple risks, subverts the long-standing traditions and ethos of the armed forces."

चीनी जासूस सुफाई की कुंडली खंगालने में जुटी पुलिस

ग्रेटर नोएडा पुलिस और खुफिया एजेंसी चीनी जासूस और ग्रेटर नोएडा में स्लीपर सेल तैयार करने वाली चीनी नागरिक सुफाई के बारे में पूरी जानकारी जुटा रही हैं। इन तीनों लड़कियों से भी चीनी जासूस के बारे में पूछताछ की जा रही है कि वह यहां अंतिम बार किससे मिलने आया था। चीनी जासूस से मिलने कौन-कौन व्यक्ति आते थे। हालांकि इस बात की अभी तक आधिकारिक तौर पर पुष्टि नहीं की गई है। पुलिस ने चीनी जासूस के दस्तावेज अपने कब्जे में ले लिए हैं। जिनमें से कुछ दस्तावेज फर्जी हैं। चीनी जासूस से पूछताछ करते पर पता चला है कि उसका फर्जी प्रमाण पत्र और फर्जी पहचान पत्र कुल 2 हफ्तों में बना गया था। इसे साफतौर पर पता चलता है कि भारत की खुफिया एजेंसी को गुमराह किया गया है। इन लोगों के जल्दी से पहचान पत्र इसलिए बनाए गए, ताकि इनको कोई दिक्कत ना हो। पुलिस अब इस मामले की जांच कर रही है कि फर्जी प्रमाण पत्र और फर्जी पहचान पत्र कहां से बनवाए थे।

रहा था वह बिल्डिंग एक मंत्री के रिश्तेदार की है। जिसकी वजह से काफी आसानी से फायर एनओसी भी मिल गई थी। ग्रेटर नोएडा पुलिस ने खुफिया एजेंसी के साथ मिलकर ग्रेटर नोएडा में मंगलवार की देर रात को

पकड़ा है, जो नेपाल, मणिपुर और एक दूसरे राज्य की रहने वाली है। इनमें से मणिपुर में रहने वाली लड़की ने बताया कि उसके कुछ दोस्त यहां पर रहे हुए थे, जिनसे वह मिलने आई थी। वहीं, नेपाल की रहने वाली लड़की का कहना है कि वह इस ग्रेटर हाउस में खाना बनाती है और इसके अलावा उसको कुछ नहीं पता है।

पुलिस को शक है कि तीनों लड़कियां पूछताछ के दौरान महत्वपूर्ण बातें छुपा रही हैं। इसकी जांच के लिए पुलिस ने तीनों लड़कियों की सोझीबार निकालना शुरू कर दिया है। जिससे यह पता चल सके कि इन लड़कियों ने पिछले दिनों किन-किन लोगों से बातचीत की है। इसके आधार पर इसकी भी जांच की जाएगी कि यह तीनों लड़कियां यहां पर कब से रह रही हैं। मिली जानकारी के अनुसार पुलिस ने तीनों लड़कियों के कब्जे से कुछ महत्वपूर्ण दस्तावेज भी बरामद किए हैं। जिनके आधार पर आगे की जांच शुरू की जा रही है।
