NCLT nod to Rel Infratel resolution plan; lenders likely to get ₹4,400 cr

Mumbai, December 3

THE NATIONAL COMPANY Law Tribunal (NCLT) on Thursday approved a resolution plan of Reliance Infratel following which lenders may get around ₹4,400 crore and Reliance Jio may pick up the assets of the debt-ridden telecom infrastructure company, according to sources.

Reliance Jio through its subsidiary placed bids to acquire assets of Reliance Communications' fully owned subsidiary Reliance Infratel which has been approved by the tribunal as part of the resolution plan, a source aware of the development told PTI.

"The lenders will get around ₹4,400 crore from Reliance Digital Platform, a group company of Reliance Jio and the successful resolution applicant," the source said.

Under the approved resolution plan approved by lenders, RCom and its subsidiary Reliance Telecom Infrastructure



(RIIL) will go to UV Asset Reconstruction Company (UVARCL), while the tower unit Reliance Infratel will go to Jio for a total consideration of ₹20,000-23,000 crore to be paid over a period of seven years.

Resolution Plan was approved by 100% votes of the committee of creditors. "Distribution of the proceeds from resolution plan is subject to the disposal of the Doha Bank Intervention Application," the source said. Email sent to the resolution professional of Reliance Infratel did not receive any immediate reply.

Max group leases 62k sq ft Noida office space to Yes Bank

YES BANK HAS taken on lease 62,500 sq ft of office space in Max Towers, Noida, as the private sector lender plans to relocate its offices from the central business district in New Delhi as part of its exercise to rationalise cost, Max Estates said on Thursday.

Besides the premium office space in Noida, Max Estates, a subsidiary of Max Ventures & Industries (MaxVII), has also constructed a luxury residential villa project in Dehradun.

Commenting on the leasing, MaxVII's managing director, Sahil Vachani told FE: "Demand for grade-A office spaces has been growing in Noida mainly due to relatively high rentals in Delhi and Gurgaon's established office space locations and emerging supply of better-quality assets".

Max Towers to consolidate its office space across several locations in Delhi is a testimony of the same, Vachani added.

In the last 6 months, Max Estates has leased around 25,000 sq ft at Max Towers to Indian Energy Exchange. It has so far leased around 3.90 lakh sq ft of space.

Sebi awaits BSE clarification before approving Future-RIL deal: Sebi has sought some "clarification" from the BSE before giving its go-ahead to the ₹24,713-crore deal between Future group and Mukesh Ambani's Reliance Industries.

In an update on November 27, the markets regulator said it is awaiting a reply to the "clarification" sought from the

BSE on the draft composite scheme of arrangement between Future Group and Reliance Group companies.

When contacted, a BSE spokesperson on Thursday said, "in the draft composite scheme of arrangement between Future Group and Reliance Group till date Sebi has not sought any clarification from BSE with regard to the NOC".

ADVANCED STAGE TRIAL 5 Indian vaccines logistically feasible for distribution, says AIIMS director

New Delhi, December 3

AIIMS DIRECTOR RANDEEP Guleria on Thursday pinned his hopes on the five Covid-19 vaccine candidates which are in advanced stages of clinical trial in India, saying they are logistically feasible for distribution in both urban and rural areas.

His assertion follows the Pfizer-BioNTech's vaccine getting emergency clearance in the UK, paving the way for



mass vaccinations from as early as next week.

Dr Guleria expressed hope that by the end of this month or early next month, at least one of the five vaccines being

locally tested should get emergency use authorisation from the drug regulator.

According to sources, global pharma giant Pfizer held talks with the Indian government late in August, but there has been no development since.

The requirement of an extremely low temperature of -70 degrees C for storing the Pfizer vaccine poses a big challenge for its delivery in a developing nation like India, Guleria said. "Five vaccine candidates are in

advanced stages of clinical trial in India and no significant serious adverse effects have been seen so far. Also, they are logistically feasible for distribution in a large country like India, both in its urban and rural parts."

"Hopefully, by the end of this month or early next month, at least one of them should get emergency authorisation from the Indian drug regulator for its distribution among the Indian population," Guleria said. — PTI

Maharashtra farmers prepare soybean seeds to prevent shortage

Pune, December 3

SOYBEAN FARMERS in Maharashtra have produced a record 36.38 lakh quintal of seeds for the next kharif season (2021-22) to prevent shortage. This is in response to an initiative taken by the state agriculture department due to early germination failure of seeds in the kharif season of 2020-21.

Dilip Zende, director, quality control, agriculture department of Maharashtra, told FE that the department had started a special campaign after receiving several farmer complaints about the quality of soybean seeds. Around 3 lakh farmers have worked on special seed plots to produce 36.38 lakh quintal of seeds,

Around 3 lakh farmers have worked on special seed plots to produce 36.38 lakh quintal of seeds, a senior official said

which is over and above the annual requirement of 10 lakh quintal in the state, he said.

The department had received around 1.7 lakh complaints from farmers. After investigation, the department found 98,000 cases of poor-quality seeds. It had filed 83 FIRs and cancelled licences of 20 seed companies, Zende said. These FIRs had rattled the industry, and as a result, several private players from Madhya Pradesh and Maharashtra had threatened to opt out of

preparing soybean seeds for the next season. The Seeds Industries Association of Maharashtra had also warned of a possible shortage.

Taking this into account, the department decided to take action and begin a campaign to prevent any shortage, he said. Normally, soybean is cultivated on 40 lakh hectare in the state requiring around 30 lakh quintal of seeds. Farmers use some 20 lakh quintals of their own and purchase the remaining from seed companies, Zende said.

Maharashtra has around 77 seed companies that manufacture soybean seeds. Inferior quality of seeds, deep sowing and insufficient soil moisture were attributed to the germination failure last season.

SC upholds GST on lottery, gambling

THE SUPREME COURT on Thursday upheld the levy of Goods and Service Tax (GST) on sale of lotteries and gambling across the country.

A bench comprising justices Ashok Bhushan, R Subhash Reddy and MR Shah ruled that the Central Goods and Services Tax Act, 2017, and the notifications issued there under bringing lottery and gambling under the GST net are valid. The court said "while determining the taxable value of supply the prize money is not to be excluded for the purpose of levy of GST." "The inclusion of actionable claim in definition "goods" as given in Section 2(52) of CGST Act, 2017 is not contrary to the legal meaning of goods..." it held.

SC concerned over violation of norms on masks, social distancing

THE SUPREME COURT on Thursday expressed concern over the violations of Covid-19 guidelines on wearing face masks and social distancing. A bench headed by Justice Ashok Bhushan asked Solicitor General Tushar Mehta and other stakeholders, for suggestions on how to strictly implement the guidelines. — PTI

DESPITE THE COVID-19 pandemic, the Gujarat Industrial Development Corporation (GIDC) is bullish of wooing new investments and aims to house more than 5,000 new industrial units at the 12 new industrial estates it is developing.

Sources said the land acquisition for nine of the 12 industrial estates, near Surendranagar, Anand, Patan, Mehsana, Chitrod in Kutch, Khirasara and Nagarpur in Rajkot district, and Khoraj on the outskirts of Ahmedabad, has been completed. "We are on

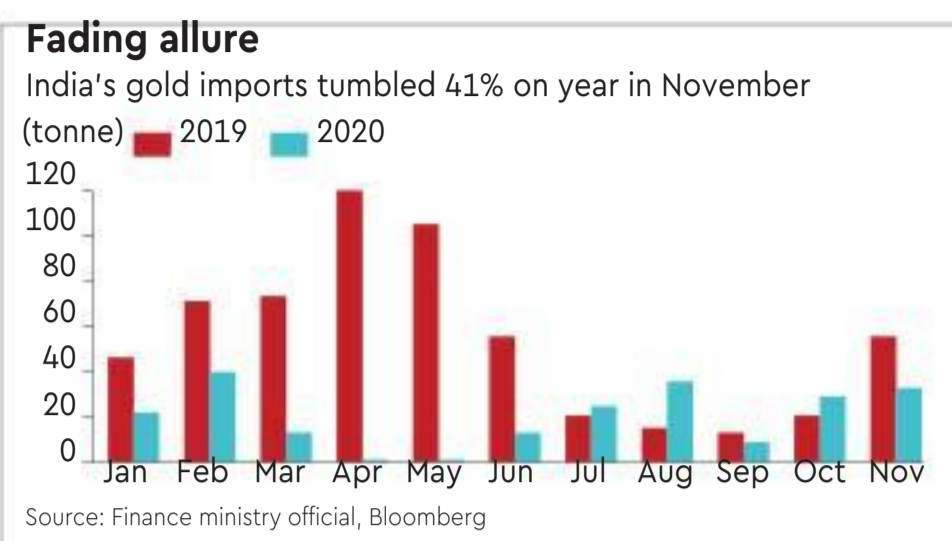

LOST SHINE

Gold imports slip in November; festival fails to revive demand

GOLD IMPORTS BY India tumbled last month as the festival of lights failed to revive demand in the world's second-biggest consumer.

Overseas purchases fell 41% in November from a year earlier to 33.1 tonnes, according to a person familiar with the data, who asked not to be identified as the information isn't public.

Still, imports showed an improvement from the 29 tons in October. Finance min-

istry spokesman Rajesh Malhotra didn't immediately respond to a call to his mobile phone. Jewellers in India may be staring at one of their worst years for sales in 2020 as the

coronavirus pandemic, high prices and a weak economy slam the ability of buyers to purchase gold.

Demand during Diwali, the biggest occasion for the country's more than 900 million Hindus to purchase jewelry, was only about 70% of last year's levels, according to the All India Gem and Jewellery Domestic Council.

India's imports in the January to November period are down 63% from a year earlier to 220.2 tons, according to Bloomberg calculations.

ED seeks fugitive economic offender tag for Mirchi family

THE ENFORCEMENT DIRECTORATE has moved a Mumbai court to get three family members of late gangster Iqbal Mirchi declared as fugitive economic offenders followed by confiscation of their assets, the agency said on Friday.

It said an application had been filed under Section 4 (read with) Section 12 of the Fugitive Economic Offenders Act of 2018 before the court "with a prayer to declare Junaid Iqbal Memon, Asif Iqbal

Memon (sons of Mirchi) and Hajra Memon (wife) as fugitive economic offenders". ED said the application also sought confiscation of their assets as envisaged under the law.

"In the first phase, prayer has been made for confiscation of 15 Indian properties, including the 3rd and 4th floor of Ceejay House (in Mumbai) having market value of about ₹96 crore and six bank accounts having balance of ₹1.9 crore."

Gujarat's renewable energy capacity set to touch 12,000 MW

INSTALLED CAPACITY OF renewable energy in Gujarat is all set to touch 12,000 MW mark in coming days due to the state government's push for solar power generation.

Sources in the Gujarat Energy Development Agency, an organisation working in the field of renewable energy development and energy conservation, said in the current financial year, the state has added around 450 MW installed capacity in renewable energy, pushing capacity to 11,180 MW from 10,730 MW.

Confirming the development, a senior official in the state energy department said that despite the pandemic, Gujarat has emerged the frontrunner in rooftop solar energy. Gujarat has the lion's share of 360 MW in India's rooftop solar addition of nearly 880 MW during the period.
