US destroyer sails past Chinese-held South China Sea islands

BEIJING: The US Navy on Wednesday sailed a destroyer close to China-controlled islands in the South China Sea in what Washington said was a patrol aimed at asserting freedom of navigation through the strategic seaway. The guided-missile destroyer USS Benford sailed past the Paracel Islands and continued thereafter with operations in the South China Sea. The operation "upheld the rights, freedoms, and lawful uses of the sea," the 7th Fleet said in a news release.



Military calls for political resolution to Lankan crisis

Sri Lanka's military and the police on Wednesday requested the Speaker of Parliament to call an all-party leaders' meeting and inform them of the steps they will take to ensure a political resolution to the "current conflict" in the run-up to the appointment of a new president.

In a statement, Chief of Defence Staff General Shavendra Silva made "a special appeal" to the people, especially the youth, to support the three forces - Army, Navy and Air Force - and the police to maintain law and order in the country. He urged protesters not to vandalise state or private property.

"We, the tri-forces commanders and the Inspector General of police have requested the Speaker (Mahinda Yapa Abeywardena) to call an all-party leaders' meeting and inform us of the steps they will take to ensure a political resolution to current conflict in the run up to the appointment of a new president," Silva said.

Sri Lanka is witnessing an escalating political crisis and a fresh wave of protests triggered by the fleeing of embattled President Gotabaya Rajapaksa from the country.

Biden made reviving the Iran nuclear deal, brokered by Barack Obama in 2015 and abandoned by Donald Trump in 2018, a key priority as he entered office.

But indirect talks for the US to re-enter the deal have stalled as Iran has made rapid gains in developing its nuclear programme.

Genocide survivors hail top-ranking Rwandan's conviction in France

KIGALI: Genocide survivors in Rwanda welcomed the conviction of Laurent Bucyibaruta, the highest-ranking Rwandan to have been convicted in France on charges related to the 1994 genocide. Many in this East African country support President Paul Kagame's efforts to get France and other countries to arrest and try all suspects still at large in Europe. Bucyibaruta, 78, was sentenced to 20 years in Tuesday's decision following his trial on genocide charges. The Paris court convicted him of complicity to commit genocide and crimes against humanity, but acquitted him of charges of war crimes and genocide, saying there was no proof that he was the main perpetrator. Bucyibaruta, who has lived in France since 1997, was not in custody during the trial but was detained by gendarmes as soon as the verdict was read. He can appeal the ruling within 10 days.

Macron govt suffers 1st defeat in Parl't

PARIS: France's government has suffered its first defeat in parliament after President Emmanuel Macron's ruling party lost its majority in elections last month. The National Assembly rejected a proposal on Tuesday night to give the government powers to demand travellers show proof of vaccination or a negative Covid-19 test when entering France. The defeat by 219 votes to 195 saw all the major opposition parties -- the far-right National Rally (RN), the hard-left LFI, and rightwing Republicans (LR) -- unite against the minority government.

Floods kill 39 in Afghanistan

ISLAMABAD: Unseasonal rains and flooding have killed at least 39 people -- including nine children -- in Afghanistan, the United Nations said on Wednesday. Fourteen other people were wounded, according to the UN's Office for the Coordination of Humanitarian Affairs. The rains have caused landslides, exposing unexploded ordnance from four decades of war and conflict. The mines are being moved and exploded under controlled circumstances to prevent further casualties, said OCHA. This is the third time that the eastern region has experienced flash flooding in less than a month, with 19 people killed and 131 people injured in heavy rains over two days in June. In eastern Nangarhar and Nuristan, some 500 families were affected.

Hindu girl abducted in Pak's Sindh

ISLAMABAD: In yet another case of atrocity against the minority communities in the country, a Hindu girl was abducted in Sindh province. The girl named Shrimati Kareena was allegedly kidnapped a week ago in Unnar Muhalla, Qazi Ahmed town in Dadu, the Dawn newspaper reported. According to the report, members of the Hindu community marched on main roads before staging a protest in front of Zardari House in Nawabshah on Tuesday in protest against what they believed was the abduction of the girl. Police claimed the Hindu girl had eloped with a Muslim boy for love and had contracted marriage with him in a Karachi court.

Pak economic crisis likely to worsen amid fast-depleting forex reserves

Cash-starved Pakistan could face a serious economic problem as its foreign exchange reserves are depleting fast amid rising external debt servicing, according to a media report on Wednesday.

The country's external debt servicing rose to USD 10.886 billion in the first three quarters of 2021-22 compared to USD 13.38 billion in the entire FY21. It was just USD 1.653 billion in 1QFY22 against USD 3.51 billion in the first quarter of 2020-21, but it jumped to USD

4.357 billion in 2QFY22 and to USD 4.875 billion in 3QFY22.

The country has been facing a serious threat from its external front as the State Bank of Pakistan's foreign exchange reserves fell to single digits despite a USD 2.3 billion inflow from China

late last month, the Dawn newspaper reported.

"The increasing size of the external debt servicing in each quarter indicates the government has been borrowing dollars at higher commercial rates to meet its foreign debt repayment obligations," the report said.
