SBI's gross non-performing assets (NPAs) declined to 8 per cent in March 2021 from 6.15 per cent in March 20. Sequentially, they were down from the proforma level 5.44 per cent in Q3FY21. Net NAs stood at 1.50 per cent, down from 2.23 per cent in March 2020 and the proforma level of 1.81 per cent in December 2020 (Q3FY21).

Its advances rose by 4.81 per cent to ₹25.39 trillion by the end of March 2021 from ₹22 trillion in March 2020. The retail loans books grew by 47 per cent. The domestic corporate loan book shrank 12 per cent.

About credit growth in 2022, Khara said the economy is estimated to grow 9 per cent and credit could expand 10 per cent, depending on the trajectory of the second pandemic wave.

Its deposits grew by 13.56 per cent to ₹36.81 trillion in 2021.

The capital adequacy ratio (CAR) improved by 68 bps to 74 per cent at the end of March 2021 from 13.06 per cent in March 2020.
