Navy told to promote victimised officer

Taking a serious view of a submarine officer resigning after allegedly victimised by a senior Vice Admiral, who wanted to promote his son-in-law, the Armed Forces Tribunal (AFT) here has ordered the Navy to promote the officer to the rank of the Captain. The victimised officer, Commander SS Luthra, had retired some

motion and will be promoted notionally and granted the substantive rank of Captain from the original date of his batch. He will be entitled to pay accordingly till the date of retirement and thereafter, pension and terminal benefits for his enhanced rank of Captain."
