Nature and details of the action(s) taken, initiated or order(s) passed	The Company and Sri Rajeswari Mills Limited have intended to refer the dispute against each other to a sole arbitrator. After hearings in front of the arbitrator, both the parties mutually agreed and signed a 'Joint Memorandum' on April 29, 2024 in respect of the ongoing arbitration proceedings. Pursuant to the said Agreement, both the parties to the arbitration proceedings have agreed to release all the present and future claims arising out of the earlier agreements (amounting to Rs 3.79 Crores on behalf of Super Spinning Mills Ltd) and any legal proceedings arising therefrom. Pursuant to this Agreement, the Ld. Arbitrator has passed a Consent Award discontinuing the arbitration proceedings without imposition of costs.
