The results of the voting by Postal Ballot will be announced by Monday, 13<sup>h</sup> January, 2020 by 5.00 p.m. at the Registered Office of the Company and the same shall be displayed on the Notice Board at the Registered Office and on the website of the Company at <u>www.firstsource.com</u>. The results shall also be communicated to the Stock Exchanges.
