



Dear Madam and Sirs,

I wish to take early retirement from active professional life in order to pursue my personal interests and passions in life.

It has been a very enriching, glorious and satisfying long journey of 28 years with the JSW Group. I remember joining as an Assistant Manager - Projects at JSW Steel's Tarapur plant on 31st December 1995. Making steady progress, I joined the Chairman's office in 2003 and it was under Sajjanji's guidance and mentoring that I got the opportunity to hone my skills with exposure to every facet of the business. I got to steer the JFE transaction independently which was the largest FDI in metal sector in 2009. My growth story is a shining example of the JSW Group's policy to develop, upskill, nurture and empower talent giving them ample opportunities to showcase their leadership qualities.

In 2017, I was given the responsibility to lead JSW Energy as JMD and CEO. It has been my privilege to steer the Company for the past 6 years and watch it transform from a majorly thermal power company to one the largest renewable energy platforms of the country.

The Company's power generation capacity has increased from 4.5 GW to 9.8 GW (with 3 GW under construction projects to be commissioned by December 2024) and has transitioned from a thermal power producer to a renewable power producer with a well-diversified portfolio of Wind, Hydro and Solar plants. The Company has successfully completed the acquisition of Mytrah assets, resulting in addition of 1.7 GW renewable capacity and Ind-Barath's thermal assets adding close to 0.7 GW thermal capacity. With these acquisitions, the Company has marked its presence across India.

The Company has achieved a unique position by foraying into new age businesses, with setting up of 1 GW Solar Module Manufacturing plant, 3.4 GWh of Energy Storage projects and 3800 TPA of Green Hydrogen production plant, the largest green hydrogen facility in the country. The Company is on its path to become a 20 GW generation, 40 GWH Storage Platform by 2030 and transition from Electron to Molecules in future. Revenues of the Company have grown by 25% during these 6 years and the Net Worth and PAT have more than doubled. Last quarter, the Company declared highest ever quarterly EBIDTA and cash profit. All this could be achieved with

Accordingly, I would like to avail early retirement from services of the Company. Consequently, I will step down from the position of Joint Managing Director & CEO, Director and as a Key Managerial Person of the Company. I will continue to helm the post till 31st January, 2024 and provide the necessary support to my successor to facilitate a smooth transition.

I am convinced that JSW Energy will continue to make spectacular progress and will achieve greater heights. I wish the Company, my colleagues and all of you the very best.
