RE-CLASSIFICATION OF MEMBERS OF PROMOTER GROUP OF THE COMPANY TO THE PUBLIC CATEGORY

The Board has received request from Mr. Dinesh Thapar, promoter category shareholder of the Company to change their status from promoter category to public category, on September 01, 2023, which was placed before the Board for consideration.

The Exiting Promoter has sold all his shareholding in the Company and as such, the shareholding of the Exiting Promoter in the Company is NIL. The Exiting Promoter is not engaged in the management or day to day affairs of the Company. He also does not have any right either to appoint any Director of the Company or an ability to control the management or policy decisions of the Company in any manner whatsoever. The Board was also informed regarding the rationale for reclassification that pursuant to procedure under Regulation 31(A) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Accordingly, based on the rationale and the confirmation provided by the Exiting Promoter in accordance with the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Board was of the view that the request given by the Exiting Promoter for reclassification from promoter category to public category be accepted and approved by the Board of Directors of the Company subject to approval of the Stock Exchange and any other such approval, if any, as may be necessary in this regard. Further the Board was informed that in terms of the proviso to the Regulation 31A(3)(iii) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended), approval of the members of the Company is not required to be obtained for above since the Promoter seeking reclassification does not hold any shares of the Company.

The Board considered the matter and passed the following resolution unanimously.

"RESOLVED THAT pursuant to the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and any other relevant provisions, including any modification(s) or reenactment(s) thereof for the time being in force, and subject to necessary approvals from the Stock Exchanges and other appropriate statutory authorities, as may be necessary, the consent of the Board be and is hereby accorded to the re-classification of Mr. Dinesh Thapar forming part of "Promoter Group" who is holding NIL shares of the company, from "Promoter & Promoter Group Category" to "Public Category.
