Re : Closure of operations of the Technical Textiles Business of SRF Industries (Thailand) Ltd.

In compliance with the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it is hereby informed that the Board of Directors of SRF Industries (Thailand) Ltd. (a material wholly owned subsidiary of the Company) had today decided to close the operations of its Technical Textiles Business operating out of Rayong, Thailand as its was becoming economically unviable to continue running the plant.

It has been decided to close the operations of Technical Textiles Business – Rayong and dispose-off the assets of the business in the manner as may be decided by the Board of Directors of that company. Necessary approvals from the concerned authorities in this regard would be taken in due course.
