### Sub.: Resignation as Statutory Auditors of City Pulse Multiplex Limited ("the Company").

In respect to captioned subject we refer our recent proposal addressed to the Audit Committee and Board with respect to immediate revision in our Professional Fees.

The same was proposed to meet the increasing infrastructural needs (costs) to align with the level of Compliance and Governance as required for the laws in force, for an Auditor to meet his duties and expectations of all the stakeholders.

The said proposal, as informed to us, was placed before the Audit Committee first and then before the Board, but was rejected unanimously by all the members of committee and Board respectively with a reason that as the company recently begun with revival of Business operations and expansion post Public Issue and thus any such increase in cost would be suicidal step for the growth of company and might affect the stakeholders.

Thus, after duly considering the Board's decision and respecting the same, we as Auditors had internal review of the said decision and were of opinion that to continue in existing fees would not be practically tenable from our end and thus have decided to resign from the said assignment with immediate effect.

We regret the decision, but at professional level we are at helpless situation. We shall extend all the required support to the upcoming Auditors with respect to past Audit data and other allied requirements. We shall also provide and extend all possible support to make this resignation effective including but not limited to issuing details as required by Exchange or other Authorities.
